#### Part 1: Current priority outcome areas

#### Wemen's skills, employment, and income

#### Labour market data

The next quarterly release of labour market data from Stats NZ will be on Wednesday 7 February. We actively monitor changes in women's employment and labour market engagement. We will provide woll with analysis of this quarter's data when it becomes available; we do not receive the data ahead of the public release

Headline information usually focuses on unemployment figures, changes in labour market participation and changes in rates of people not in employment, education or training (NEET).

We will also review trends for part time workers, changes due to an aging population, trends for Māori and Pacific women, and occupational shifts in areas where we have been active such as the construction industry.

# Gender pay gap guidelines for businesses

We are providing advice to Stats NZ on the development of high level guidelines for employers on the measurement of gender pay gaps within individual organisations. A first draft has been circulated to us and SSC for feedback. We hope that providing guidelines about how to measure the gender pay gap will encourage employers to both measure their gap, and take steps towards closing the gap.

Guidelines will complement our work on tools for measuring the gender pay gap. We are working with Global Women to get feedback from their partner organisations about tools that organisations could use to close their gender pay gap.

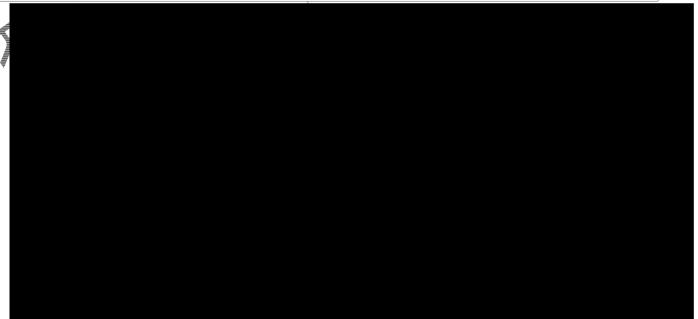
#### National Council of Women comments on Global Gender Gap Index

The National Council of Women of New Zealand (NCWNZ) February newsletter is critical of New Zealand's fall to ninth place in the World Economic Forum Global Gender Gap Report 2017 global d Andrew Control of the Control of t index, which is down from sixth in 2012 and fifth in 2009 four highest rankings in the period 2009-17). NCWNZ cite as concerns:

- the gender pay gap for Pacific women,
- bullying experienced by transgender students,
- women's unmet needs for primary health care, and
- underrepresentation of women in Parliament.

#### Women in Technology - Tech Week 2018

We attended an interagency meeting hosted by MBIE about Tech Week 2018 (19-27 May). Tech Week is an annual festival made up of a number of events across New Zealand celebrating and promoting New Zealand's technology industry. Tech Week is run by NZ Tech and this year's principal sponsor is MBIE. We are considering options for our involvement in Tech Week, including promoting 'Decoding Diversity', our guide for training and education providers to attract more women and girls into technology education. We will keep you informed about this.

#### Apolitical gender equality show and tell

We led the first Apolitical gender equality 'show and tell' teleconference in which Dr Gail Pacheco discussed *Empirical Evidence of the Gender Pay Gap in New Zealand*. Apolitical is a free online platform helping governments and their partners to share practice and ideas in over 120 countries. The discussion was the first of a series of monthly conversations in which organisations share their work and answer questions from women's rights policy specialists from around the world. Teleconference attendees included:

- Lisa Witter, co-founder of Apolitical
- Siobhan McKenna, senior diversity and social policy advisor to the Mayor of London
- Professor Amy G Mazur at Washington State University, who is leading a research project on equal pay laws in western countries
- Julie Reilly, CEO of the Australian Women Donors' Network 4
- Janin Bredehoeft, Senior Research Advisor at Australia's Workplace Gender Equality Agency

In addition to Dr Gail Pacheco sharing our research with women's rights policy experts, we were able to take away innovative policy ideas and helpful initiatives from other countries about similar work they are doing to tackle their gender pay gaps, especially within the public service in Australia and the UK. # The Ministry's future working relationship with the system response to domestic and sexual volence

On 25 January we met with Sarah Holden, the new head of the Multi Agency Team (MAT). We discussed options for our contribution to the domestic and sexual violence system, particularly our future working relationship with the MAT, and opportunities to embed gender analysis in the future domestic and sexual violence system. One of the options we are considering is seconding Ministry staff to the MAT. We will keep you informed of progress.

Following the preeting with you, Undersecretary Logie, and Ministry of Justice officials on 31 January, we will provide you with a briefing to outline details of our work programme in the domestic and sexual violence system. We anticipate sending this to your office by 15 February.

#### Women's representation in leadership

#### NZX gender diversity data

The New Zealand Stock Exchange (NZX) has released its latest gender diversity data, which shows gains for women on the NZX listed boards:

- Women's representation on NZX listed boards increased from 17% in 2016 to 19% in 2017
- Women's representation on S&P/NZX top 50 boards increased from 22% in to 27%

In late 2017 we provided you with advice on actions that can be taken to increase women's representation on private sector boards in New Zealand (MW 17-18 0142 refers) for discussion at a future officials meeting.

#### Select Committee hearing

#### March Baseline Update

A Treasury Circular (2017/16) dated 21 December covers the March Baseline Update (MBU) process. This process is a technical update where changes can be made with Joint Ministers' approval. Copies of submissions are due with the Minister of Finance by Monday 26 February.

To ensure these deadlines are met, we propose to provide a briefing to your office by 14 February.
