Launch of Parenthood and Labour Market Outcomes research

We released the Parenthood and Labour Market Outcomes research report [MW 17-18 0375 refers] on Tuesday 29 May to keen interest from policy agencies. Approximately 75 representatives of NGOs and social agencies attended the policy forum to launch the report, which was also live streamed. Participants asked questions about the research and the implications of the findings for social policy.

The research, commissioned by the Ministry and conducted by Motu Public Policy Research Institute and The New Zealand Work Research Institute at AUT, was the front page item in the print edition of the NZ Herald; it was reported on Radio New Zealand's (RNZ) Morning Report; co-author Isabelle Sin was interviewed on RNZ's Nine to Noon, and it was covered in a number of blogs.

The research findings will inform our policy advice, especially regarding how women earning low incomes engage in the labour market; financial literacy; flexible work, parenting norms; and advice to employers on closing gender pay gaps. We are planning an event in Auekland for you to host and share the findings with stakeholders.

Addressing like-for-like gender pay gaps: initial workshop with Public Service Human Resources staff

On Monday 28 May, SSC and the Ministry hosted a workshop for approximately 45 remuneration, employment relations, and human resources leads, representing 26 public service departments and four crown entities. The workshop discussed your Gender Pay Gap Strategy, with a particular focus on closing like-for-like gaps. We understand some agencies may start identifying and closing like-for-like gaps alongside this year's remuneration round. Participants provided feedback on the guidance they will need, and heard from MFAT and Corrections on their processes. The feedback will inform the Ministry and 92 SSC's guidance on calculating gender pay gaps and closing like-for-like gaps.

Toi Tū Te Whānau, Toi Tū Te Kāwai Whakapapa workshop on whānau and whakapapa for public policy

On Tuesday 29 May, Ministry staff attended Toi Tū Te Whānau, Toi Tū Te Kāwai Whakapapa, a workshop organised by Superu to challenge policy makers to be enablers of whānau wellbeing. Hon Nania Mahuta, Minister for Māori Development, welcomed the opportunity to korero about policy design to support a productive economy and the wellbeing of all families, especially Māori whānau. Important discussion points included a focus on single-parent families is considered to be a deficit approach to thinking about whanau; culture is a protective factor from poverty and harm when raising children; and analysis without cultural context can create real harm. Dame Tariana Turia spoke on the importance of whānau ora as a policy-making concept to improve outcomes for whanau and children. The themes of the conference enhance our understanding of the social policy context, especially considerations for whānau Māori.

On Thursday 24 May, we teleconferenced for a second time with staff at the Government Equalities Office (GEO), United Kingdom (UK). We discussed in more detail their programme to develop evidence-based advice on tackling gender pay gaps; their views on how the UK regime could be strengthened; that payroll services providers need sufficient time to make system changes for pay reporting regulations; and their *Shared Parental Leave* campaign. Increasing the safety from violence of women and girls

Launch of new research: New Zealand Teens and Digital Harm: Statistical insights into experiences, impact and response

The second report of the Ministry for Women and Netsafe research partnership on digital harm will be released in an online launch by Netsafe on Tuesday 5 June. New Zealand Teens and Digital Harm: Statistical insights into experiences, impact and response was led by Netsafe and complements the Ministry-led research, Insights into Digital Harm: The online lives of New Zealand girls and boys, which you launched in December 2017.

The research suggests that Kiwi teenagers are twice as likely as adults to be negatively affected by harmful communications online and that girls are at greater risk of harm than boys. Girls are more likely to receive unwanted digital communications and to be adversely affected than boys.

Netsafe has shared a summary of the findings with the Ministry of Education, the Ministry for Justice, the Office of Disability Issues, and UNICEF New Zealand. A second set of stakeholders will be briefed on the findings ahead of the release.
