# Launch of the Gender Pay Principles for the State sector

You are co-hosting the launch of the joint State sector union/agency Gender Pay Principles for the State sector on Monday 2 July in the Grand Hall at Parliament. You will be speaking at the launch with the Minister for State Services, the State Services Commissioner and Erin Polaczuk, PSA National Secretary. There will be a wide range of public service employees, employers and unions attending. You have a received a briefing with further details of the launch, the guest list, speaking points and a draft press release from you and Minister Hipkins. Please note the speaking points do not refer to the Government agreement to the gender pay gap strategy, which will be confirmed on Monday 2 July. This is allows officials time to consult with State sector agencies and State sector unions on the outcome of Cabinet consideration before an announcement is made.

### APEC Women and the Economy Forum

We are working with MFAT and SSC to prepare for the APEC Women and the Economy Forum (the WEF) to be held from 3 to 7 September, in Papua New Guinea. The WEF is a key event on the APEC calendar and includes a meeting of the Policy Partnership on Women and the Economy sub-group, for which the Ministry is New Zealand's lead agency. Ministers are invited to attend part of the WEF, however we will advise Minister Sage, as Acting Minister for Women, that she does not need to attend. We are investigating whether an SSC senior official will lead the delegation, supported by a Ministry official. We will provide you with a briefing on 26 July 2018.
