Equal Pay Amendment Act

United Kingdom Committee report on gender pay gap reporting

The Business, Energy and Industrial Strategy Committee of the House of Commons published the report of its inquiry into the UK's new gender pay gap reporting regulations on Friday 2 August. The regulations require employers with more than 250 employees to report their mean and median pay and bonus gender pay gaps, and the distribution of pay to men and women in their organisations by pay quartile. The first annual reports, from over 10,000 employers and covering approximately half of the workforce, were submitted in early April 2018, and the initial impact of the regulations can be assessed. The first found of reporting achieved 100 percent compliance.

The Committee has recommended that the government strengthens the regulations, by lowering the threshold for reporting to 50 or more employees, and by requiring companies to publish explanations of their gender pay gaps and action plans for addressing them. It found a lack of clarity and detail in the guidelines, which has led to some inaccurate reporting, and to equity partners (especially in law firms) being excluded from employee data. As a result, law firms have reported much lower gaps than if partners had been included. The Committee also recommended that the Equality and Human Rights Commission, which has oversight of the regulations, have stronger sanctioning powers, including imposing fines for not reporting, or for deliberate inaccurate reporting. We will continue to monitor the impact of regulations on the UK to inform the implementation of the GPG Action Plan.
