### Part 1: Current priority outcome areas

### Suffrage 125

We have received positive feedback on the Suffrage Day event at Parliament. The majority of guests were people who would not normally attend events in Parliament. The image of Meri Te Tai Mangakāhia now resides in the Suffrage Room in Parliament. The wider whanau have expressed their thanks and intend to visit Parliament to view this image of their tupuna. The event was extended beyond the venue through the RNZ livestream and this has already been viewed more than 5,400 times.

We have paid all but two of the Suffrage 125 Community Fund applicants. We are in discussions with these last two to finalise the necessary requirements before funds can be paid.

There has been extensive media coverage of Suffrage 125 events throughout New Zealand, as well as items about issues affecting women and girls. We will continue to liaise with media to highlight these issues, and in particular, when they relate to the work of Ministry for Women. On social media the hashtags relating to this celebration were in the top 10 trending items last week.

There have been 311 Suffrage 125 events listed on the website since we began the events page in January 2018. These include 100 events that are current or still to occur. In addition, there have also been events within businesses and organisations. There will also be more events in the lead-up to 28 November when we mark the 125th anniversary of women voting for the first time in a general election. This will signal the formal close of Suffrage 125 anniversary celebrations.

### Òranga Tamariki – Pay Equity settlement

On Tuesday 25 September 2018, Minister for Children Tracey Martin announced an agreement in negotiations on pay equity between Oranga Tamariki and the PSA has been reached. This agreement leads to a significant uplift in pay for social workers under coverage of the claim. Pay increases to reflect this will be phased, with the first increase scheduled for 1 December 2018 and the second on 1 December 2019. Our understanding is that Pay Equity will be achieved following the implementation of phase two.
