Gender Pay Gap and Pay Equity Taskforce Update

Action plan workshop

On 5 November 2018, the Taskforce, together with the PSA, delivered the first in a two-part workshop series on developing agency gender pay gap (GPG) action plans. Around 80 agency human resources staff, PSA delegates and PSA organisers attended, indicating a very high level of engagement with this process. The workshop provided an overview of the causes of the GPG, commitments in the recently launched gender pay principles and public service GPG action plan, plus the pay equity context.

Three case studies were also presented: flexible-work-by-default approaches within the Department of Conservation; identifying and correcting gender pay gaps in the same or similar roles within the Ministry of Foreign Affairs and Trade; and how a gender pay gap analysis has led to a wide ranging review of pay and employment processes within Housing New Zealand.

Two follow-up half-day workshops are planned for 15 and 19 November 2018. These will provide an opportunity to engage in detail with the draft guidance on measuring gender pay gaps that has just been distributed and plan how agencies will develop their plans for employees and agencies. We will provide a briefing on the launch proposal by 16 November 2018.

Round-table discussion on women, equality and ageing on 31 October

In conjunction with the Australia-New Zealand School of Government (ANZOG) the Ministry hosted its 2018 visiting Fellow, Professor Pamela Herd, at a round-table discussion among senior public servants on her research findings on women, equality and ageing.

The event brought together senior officials from both social and economic ministries and generated significant interest among participants, all of whom identified areas of direct relevance to their work. Professor Herd drew on large international datasets, including New Zealand datasets, to identify key determinants of unequal health and mortality outcomes. She showed how unequal access to healthcare among Māori women in mid-life impacts on health inequalities in later life. Significantly, for the government's wellbeing focus, she presented compelling evidence that social networks and social capital are significantly greater determinants of ill health and early death than any of the following factors: obesity, smoking, and physical activity. Her presentation and bibliography will be available on the ANZSOG website in the near future and will inform our policy work.

System leadership, impact and reputation

National Library public event on sustainable development goal (SDG) five: Gender Equality

The National Library invited the Ministry to present at a public forum on 7 November as part of an international library associations' initiative to raise public awareness of the role of libraries in supporting achievement of SDGs. As a suffrage year initiative, they selected goal five as the focus for this session, as the first of a series. The meeting was attended by around 40 people, including some from women's NGOs. The Ministry, along with MFAT, participated as part of a panel of speakers that included senior library staff. We outlined the general approach the government is taking to the SDGs, and goal five in particular, describing actions the government has underway in progress towards the goal. The panel presentations, and the question and answer session that followed, highlighted the useful role libraries play within communities in bringing diverse New Zealanders together to build and share knowledge and exchange ideas. The Ministry intends to engage with the National Librarian and explore ways that libraries can build stakeholder engagement on priority issues in the Women portfolio.

Suffrage 125

Recent survey results show that 54 percent of New Zealanders were aware of Suffrage 125, a high level of awareness for a programme of this size. We used Colmar Brunton to survey a representative sample of 998 New Zealanders in October to measure awareness and impact of the programme. The results of the online omnibus are weighted by age, gender and region to be representative of the overall New Zealand population. They showed that three percent recall attending a Suffrage 125 event or activity (in terms of numbers of people, the three percent equates to approximately 89,886 people aged 18+, based on the 2018 population estimates from Stats NZ). We have provided further details on this survey and a detailed breakdown of achievements in our recent briefing on the evaluation of the Suffrage 125 programme.
