

# Ministry for Women Weekly Report to the Minister for Women

#### Meeting with Minister for Māori Development

We have provided talking points for your meeting on Thursday, 7 March 2019, with Minister Mahuta on the joint work programme with Te Puni Kōkiri and the Mana Wāhine Kaupapa Inquiry.

#### Carers' Strategy Action Plan

You have received a letter from Minister Sepuloni seeking your support through the Cabinet process for the NZ Carers' Strategy Action Plan, in both your roles as Minister for Women, and Associate Minister of Health. In particular, Minister Sepuloni is asking you to consider signing the Action Plan as a population portfolio Minister, and support:

- measures to support women carers to continue to participate in their community, study, and work, while undertaking caring roles
- increased recognition of all carers, while acknowledging the majority of carers are women
- the improved quality, availability, and flexibility of respite support
- the continued progress of the Ministry of Health's work to address the Funded Family Care issues.

We will provide advice on 26 March 2018 to respond to Minister Sepuloni's letter.

We will continue to work with the Ministry for Health (and other agencies) to provide you with a response to the Carers' Strategy Action Plan, and consider how to include the plan as part of our work programme on the contribution and value of women's unpaid work.

#### Recent Labour Market reporting

#### HLFS (Household Labour Force Survey) - last quarter

The Ministry for Women and the Reserve Bank both followed up with StatsNZ on understanding the background to the adjustments that had been made to the last quarter's labour market statistics.

StatsNZ found that a portion of respondents deliberately misreported their labour force status (from 'employed' to 'not in the labour force (NILF)') to avoid additional Survey of Working Life questions. StatsNZ therefore adjusted some NILFs into the 'employed' category. We support this approach.

#### NEET (not in employment, education, or training)

Last quarter, StatsNZ made more contacts toward the end of the survey period due to the effect of survey avoidance. This increased the chances of capturing school leavers who were not in paid work, or enrolled in education. StatsNZ considers the NEET rate for the December quarter should be used cautiously. Agencies do expect NEET rates to rise for the December quarter and, because of small numbers, make annual comparisons.

The HLFS has been reporting a decline in female NEET rates, from roughly double the rate of males in 2004 – 2006, to roughly equivalent rates in 2017 and in 2018. We attribute this to reduced numbers of NEET young women caring, corresponding with reduced recorded births for this age group. We are waiting on Census 2018 results for more detail on NEETs, such as by ethnicity and sex. We have also recently spoken with Ministry of Social Development officials about research to understand the fall in numbers of young mothers and have provided them with contacts and recent research to assist with this.

Key themes raised by submitters included: issues of accessibility to information and a desire to have access to a separate pay equity unit/agency. The provisions for back pay were criticised by some submitters as being confusing.

#### International Women's Day and the Commission on the Status of Women (CSW63)

The Ministry has continued to receive enquiries from organisations for activities and events on International Women's Day 2019 (Friday, 8 March 2019). We have promoted the website listing of events on social media, to encourage participation.

Several Ministry officials will attend the UN Women/Zonta breakfast at Parliament, and take part in the bike ride at lunch time (weather dependent), on Friday, 8 March. Three officials are attending a British High Commission stakeholder event on Thursday evening, 7 March, and one is attending an event on Saturday, 9 March, with the High Commissioner of Malaysia in collaboration with the National Council of Women of New Zealand and the Multicultural Council of Wellington. Another official is attending, also on Friday, 8 March, the NZCTU International Women's Day launch of the film *Harriet Morison: Unionist and Suffragist*. This is a film that received funding from the Suffrage 125 Community Fund. These events are useful opportunities for stakeholder engagement on the Ministry's work.

The focus next week, the week beginning Monday, 11 March 2019, will be to share the activities from the Commission on the Status of Women, particularly the presentation of the National Statement.
