Pay Equity Work Programme - consolidation consultation

These meetings have been informative and useful so far. We will continue talking with MBIE to progress an agreed approach.

Pay transparency

Global Women has worked with McKinsey and Co, and the Ministry for Women, to develop a survey on pay transparency. This will be sent out to the members of the Champions for Change by 8 June 2019. The survey results will be discussed at the Champions for Change meeting on 28 June 2019.

The new chair of Global Women, Anna Stoke, is seeking feedback on pay transparency from a small group of members, to feed into this process. We are expecting a draft report back by the end of June, and a final report from Global Women by 12 July 2019.

We have also discussed the idea of a pay transparency survey with Super Diverse Women, whose members tend to be small and medium sized organisations. We are meeting with Super Diverse Women in mid-June, and will keep you updated on whether they will undertake a survey.

Release of the New Zealand Crime and Victims Survey 2018

In May 2019, the Ministry of Justice released results of Cycle 1 (March – September 2018) of the New Zealand Crime and Victims Survey. This new survey replaces the New Zealand Crime and Safety Survey, which was last undertaken in 2014.

We will undertake analysis of the findings of the new survey, and will provide you with a summary of the results relating to women's safety by 14 June 2019.

We will also prepare a new version of the fact sheets document, to include the data from both this survey and the new Household Labour Force Survey issued on 1 May 2019.

System leadership, impact and reputation

International - Women Deliver 2019, Vancouver, Canada

The conversations in the first half of the week at Women Deliver 2019 in Vancouver have focused on how to advocate for faster change to achieve gender equality.

One of the themes has been how areas such as women's education, health, finances, and access to technology, are interconnected to improving women's wellbeing.

The Canadian Government has used the conference to promote its progress on gender equality. Prime Minister Trudeau said "when we prioritise women, everyone wins".

There are over 8,000 delegates attending, and numerous plenary, concurrent and side events covering a wide range of issues. The Ministry has one official attending and you will receive a briefing in July.

International - Letter from the Inter-Parliamentary Union

The Ministry has been made aware that the Secretary General of the Inter-Parliamentary Union (IPU) has written to the Speaker of the House, the Rt Hon Trevor Mallard, regarding New Zealand's CEDAW examination and Concluding Observations. The IPU letter draws attention to the four CEDAW recommendations to be considered for early attention. It asks that the Concluding Observations be made available to members of Parliament in order to facilitate a debate to ensure adequate follow-up. The Speaker has replied, thanking the IPU for drawing his attention to the Concluding Observations and copying in Hon Anne Tolley MP, Raymond Huo MP, and the Chairpersons of the Justice and Health Committees.

The IPU works closely with the United Nations, and was established in 1889. The IPU comprises 179 Member Parliaments, including New Zealand, and is committed to promoting democracy, equality, human rights, development, and peace. Members work together for positive change, both in their own countries and at international level.
