Mana Wāhine roopū update

Current focus

 On 23 November 2020, Chief Judge Isaac appointed Professor Linda Tuhiwai Smith as a member of the Mana Wāhine Kaupapa Inquiry panel. Professor Tuhiwai Smith joins Dr Robyn Anderson, Kim Ngarimu, and Dr Ruakere Hond as panel members, in addition to Judge Sarah Reeves as the Presiding Officer.

Period poverty

Ministry officials attended a webinar on 'Achieving Period Equity in Aotearoa' arranged by Miranda Hitchings and Jacinta Gulasekharam from Dignity, with counsellor and educator Caro Atkinson, and obstetrician, gynaecologist and Global Women leader, Dr Emma Parry.

Groups such as Dignity, and others advocating for period poverty, are likely to contact you to discuss what further work may be required on addressing period poverty. They are interested in: access to period products, the impact of school absenteeism due to period poverty and menstruation issues on girls education outcomes, product choice, sustainability, and menstruation education. Many of these potential issues were raised with the Manatū Wāhine Ministry for Women during the development of the period products in school initiative being implemented by the Ministry of Education (MoE). As the current funding for the school period product initiative runs until the end of June 2021, we have been supporting MoE with its work to secure further funding for this initiative.

Three-part governance training pilot completed

The Ministry has now delivered three governance essentials training courses in Auckland, Wellington and Christchurch. The objective of the courses is to support new people from a range of backgrounds into public sector governance. This work is part of the Nominations service work programme to support a development pipeline for potential Directors.

The Ministry partnered with the Office of Ethnic Communities, Ministry for Pacific Peoples, and Office for Disability Issues, to deliver these courses. The training was facilitated by Governance New Zealand. In total, over 50 people attended the sessions with participants including wāhine Māori, and people from ethnic, Pacific, and disability communities.

Participants said they were very excited to see government agencies collaborating for this training, and that they would like to see follow on events. The Ministry will now process the evaluation forms, review the training, and work with relevant population agencies to plan inclusive governance activities for 2021.

The Ministry will provide a briefing in late January on the Nominations work programme for 2021.

Pay Equity tools and resources published

The Gender Pay Taskforce has published Pay Equity tools and resources on the Te Kawa Mataaho Public Service Commission (the Commission) website to support the implementation of the amended Equal Pay Act 1972, which came into force on 6 November 2020.

The suite of Pay Equity tools and resources were developed by the Commission with input from, and in consultation with, state sector agencies and the New Zealand Council of Trade Unions Te Kauae Kaimahi. The Taskforce also considered feedback from practitioners who have used our tools and resources for their claims processes to date.

The Taskforce is supporting the Ministry of Business, Innovation and Employment in its implementation of the Equal Pay Act 1972, including with development and adaption of tools and resources for the wider economy.
