# Part 1: Current priority outcome areas

## Mana Wāhine roopū update

#### Tūāpapa hearings

- The joint roopū is providing you and Minister Jackson with a memorandum on the first tūāpapa hearing on 18 February 2021. A further memorandum will be provided after the second tūāpapa hearing which is being held from 24-26 February 2021 at Tūrangawaewae Marae, Ngāruawāhia.
- On 16 February 2021, Judge Reeves issued Memorandum-Directions concerning the tūāpapa hearings. We are working with Crown Law Office on a requested Crown update on reimbursement of claimant funding which is due on 22 February 2021.
- The third tūāpapa hearing has been confirmed as being from 12-16 July 2021 at a location in, or near, Whangārei. Should you be able to attend this hearing, or others later in the year, we can advise you further in this regard.

#### Research

Progress is being made with the membership of the Joint Research Committee as Judge Reeves has confirmed the list of claimant representatives. We are in the process of establishing a Crown Research Committee, and a representative from that group to serve on the Joint Research Committee.

#### Interdepartmental Governance Groups

The Ministry's Chief Executive (in her role as Co-Chair of the Interdepartmental Steering Group) recently wrote to her counterparts at New Zealand Police and Corrections requesting they provide senior officials to join the Interdepartmental Working and Steering Groups. Both have responded positively which will provide helpful perspectives on the claims that relate to criminalisation and access to justice.

This week, the joint roopū will host the Interdepartmental Working Group to update senior officials from 11 agencies on the first tūāpapa hearing and discuss the All-of-Government Framework development.

#### Family Harm Coordinators course

Recently, a Ministry official conducted a session on women and family harm, with an interest in culturally and linguistically diverse families in New Zealand, at the Family Harm Coordinators course held at the Royal New Zealand Police College.

Family harm specialists attend this course from across the country. The theme of this course was partnerships and the importance of language in recording information. This is the third course the Ministry has been a part of, giving participants an insight into the gendered nature of violence, intersectional experiences, and international data and trends. It gives the Ministry an opportunity to engage directly with the family harm specialists and understand their experiences with diverse communities.

# System leadership, impact, and reputation

#### International

For Gender Equality (4GE) meeting

On 12 February 2021, Ministry officials met virtually with our counterparts from Australia and Canada; unfortunately our colleagues from the United Kingdom were unable to join the meeting. At this meeting, we discussed preparations for upcoming Commission on the Status of Women (CSW) events, such as our proposed side events, engagement with civil society organisations, and approaches to National Statements and Agreed Conclusions. We also indicated that we would like to organise bilateral calls for you with the Australian Minister for Women and the Canadian Minister for Women and Gender Equality.

#### International Women's Caucus

The first International Women's Caucus meeting of the year took place on 16 February 2021; although initially planned as an in-person event, it was moved to a virtual format at short notice due to the adjustment in COVID-19 alert levels. Topics discussed included NGO involvement in CSW events, the Mana Wāhine Kaupapa Inquiry tuāpapa hearings, and the work of the Joint Venture on Family Violence and Sexual Violence.

The Caucus members indicated that they would like to meet with you at the next Caucus meeting on 18 May 2021; an invitation has been sent to your office for consideration, and if you choose to accept the invitation we will provide a full event briefing.

Key requests from the Caucus were:

- need for an overarching National Action Plan for women
- greater awareness of CEDAW (Committee on the Elimination of Discrimination against Women)
- involvement in the Commission on the Status of Women this year.

65th session of the Commission on the Status of Women (CSW65)

Preparations for CSW65 are ongoing, although this event will have less ministerial involvement than in some previous years due to its virtual format. Your role is to approve the New Zealand National Statement and delegation, and attend and speak at your hui, to be held on 15 March 2021.

Each year, a major output of CSW is the Agreed Conclusions document. This week, we have provided comments to the CSW secretariat on the first draft of the Agreed Conclusions, focusing on maintaining progressive language in areas such as sexual and reproductive health and rights, safety from violence, climate change, and closing pay gaps. The Ministry of Foreign Affairs and Trade has led discussions on behalf of New Zealand to develop shared proposed edits with the Pacific bloc (Fiji, Australia, Tonga, Samoa, Tuvalu) and with the Mountains group (Norway, Australia, Switzerland, Canada, Iceland, Liechtenstein).

At the Caucus meeting this week, members indicated their strong preference for an NGO representative to be on the delegation as has been the case in recent years. We are working through a process to ensure that any NGO representation on the delegation is meaningful and transparent.

Work is continuing on the CSW65 hui that we are hosting; on your behalf, the Joint Venture has agreed to facilitate a workshop at this event on next steps for eliminating gender-based violence. Rebecca Barnes, Policy Director, has also been invited to speak at a parallel event, the Fair Pay Roundtable, hosted by Fair Pay Innovation Lab, Foundation for European Progressive Studies, PES Women, and Fondation Jean Jaurès.

Further information on all the above, along with a draft National Statement for your approval, will be provided to your office next week.

# Part 2: Operational matters

#### Staffing - collective employment agreement

The Ministry and the Public Service Association (PSA) have agreed to extend the current collective employment agreement (CEA) until 17 July 2021 to allow the joint Ministry and PSA Performance and Remuneration Working Group to complete its work programme.

The Working Group was created following ratification of the April 2019 CEA. The Ministry and PSA have been working, for the last year, on a new performance and remuneration process for staff based on adopting a coaching-based process for staff development. This extension will allow the Working Group to finalise the new performance and remuneration model to be put forward for ratification in May 2021. If the new model is agreed, the current CEA will be extended to April 2022, giving it a full three-year term, when then, in 2022, the Ministry and the PSA will enter a formal bargaining round for a new CEA.
