Mana Wāhine roopū update

Mana Wāhine Kaupapa Inquiry tūāpapa hearing two – Ngāruawāhia, 24-26 February 2021

- The second tūāpapa hearing commenced on Wednesday 24 February 2021 at Tūrangawaewae Marae, Ngāruawāhia.
- There are 28 witnesses covering 16 claims to be heard over the three days of the hearing.
- Similar to the first tūāpapa hearing, there is evidence being presented on the concept and origins of mana wāhine: where it comes from, how it is passed down, and how it is maintained and asserted.
- Some topics being covered by witnesses in this second hearing include:
 - Mana Atua, atuatanga as it is reflected in the Waikato; includes reference to the Waikato awa (river) as a female entity
 - o predominant wahine rangatira and sacred Maori femininity through the nga wahine atua
 - o gender identity and sexual expression
 - health-related topics, including the suppression of w\u00e4hine tohunga and practice of rongo\u00e4; M\u00e4ori nurses in birthing, cervical screening, and theatre nursing; nursing practices and cultural safety and pay equity in the health system
 - New Zealand Māori Council and impacts of urbanisation on wāhine Māori.
- Reimbursement of claimant costs to date, we have received expenses costs from eight claimants, which have been paid. Two requests for exemptions to the reimbursement guidelines have also been received, and processed.
- A joint memo will be provided to you and Minister Jackson on 18 March 2021 to provide a more detailed update.

Te Taumata Board

Te Taumata Board (which partners with the Ministry of Foreign Affairs and Trade in relation to trade negotiations) has announced two wahine Maori appointments to join its board.

Tania Te Whenua (one of the claimant counsel in the Mana Wāhine Kaupapa Inquiry) and Carrie Stoddart-Smith (founder of OpinioNative, an independent Māori consultancy focused on indigenous trade and economic issues) have been appointed. Te Taumata Board Chair described the appointments as adding a deeper dimension to the board from both a gender and iwi representation perspective.

Governance speaker and networking event

The Nominations team is working with the Office of Ethnic Communities, the Ministry for Pacific Peoples, and the Office for Disability Issues, to hold a networking and speaker event for the Nominations database members. The event is in response to requests from database members and follows on from the governance training we ran in November 2020.

The event will be tailored towards database members who are developing their governance careers. It will include current experienced board members from diverse communities as speakers, and will provide time for networking. We have also invited appointing agencies to attend the event and meet aspiring board members.

The event will be the evening of Tuesday, 23 March 2021, at Te Tari Taiwhenua Department of Internal Affairs, in Wellington. This will be a pilot event and, if successful, we will aim to offer a similar event in Auckland.

2021 government appointments

The Nominations team have responded to 21 requests for candidates for government appointments, since the start of the year. For each of these requests, the Ministry has nominated candidates from our database. These have included nominating women for the New Zealand Trade and Enterprise Board, New Zealand Meat Board, Oranga Tamariki Residence Grievance Panels, and the Building Practitioners Board.

The schedule of government appointments to be made in 2021 shows that there are over 700 board terms for members ending or already expired. Not all of these positions will come up for appointment, as some will be reappointments. The Appointments and Honours Committee (APH), where you are a member, will approve all of these appointments and reappointments. These appointments provide an opportunity to maintain a strong representation for women, alongside a focus on increasing the appointment of wāhine Māori and women from other diverse backgrounds. The appointing agencies provide advice to APH on the impacts of each set of appointments on the make-up of individual boards to help assist APH in their decision-making.

Analysis of state sector board data for 2020 annual stocktake of gender, Māori, and ethnic diversity on state sector boards and committees

To begin work on the annual stocktake, the Nominations team has entered all of the data on state sector board members from the organisation forms received from the Department of Prime Minister and Cabinet. This data will provide an overview of gender, representation for Māori, and ethnic diversity on state sector boards as of 31 December 2020.

Reporting on representation for Māori and ethnicity has already improved from last year, with a tentative response rate of 95 percent. The Nominations team is currently following up with agencies that have provided insufficient data.

Initial analysis indicates that the statistic for women's representation on state sector boards is slightly over 50 percent; this will be confirmed once the data analysis is complete.

We will provide you with a Cabinet Paper for the Cabinet Appointments and Honours Committee confirming these numbers in April 2021, and further information on the proposed release of the data from the annual stocktake.

National Strategy for Financial Capability

The Ministry for Women hosted the Commission for Financial Capability (CFFC) on Wednesday 24 February 2021. CFFC is refreshing the National Strategy for Financial Capability, which aims to improve New Zealanders understanding of money. CFFC has a number of resources for women but this is the first time the National Strategy will include a response focus on women. CFFC met with the Ministry to use knowledge of issues such as the gender pay gap, women's employment, and pay equity, to inform the development of the Strategy.

Employment, Education and Training Ministerial Group

The terms of reference for the Employment, Education, and Training (EET) Ministerial Group have been updated to include officials from the Ministry, and Te Puni Kōkiri, in the working level groups. This change will allow the Ministry to engage earlier in policy and forward work programmes to ensure a gender perspective is incorporated into advice in the early stages. We anticipate that this change to the terms will allow for better information flows to you on initiatives that affect women, and influence in the early stages of policy work with your colleagues.
