COVID-19 work programme

Cabinet paper: Building Resilience for Women: COVID-19 and Beyond

The revised Cabinet paper is with your office and the Department of Prime Minister and Cabinet for comment, and we are meeting with the EET Secretariat this week to discuss the actions we are proposing in the revised paper. Once we have addressed any additional comments, we propose that Ministerial and agency consultation commences from Tuesday 16 March 2021. The Cabinet paper is on the EET Ministers group meeting for discussion on 25 March 2021 (11.30am to 12.30pm) and we will provide you with talking points for this meeting.

International Women's Day events and launches

The events and information released for International Women's Day 2021 highlighted the contributions of women and drew attention to issues such as the gender pay gap and women in leadership roles. The UN Women and Zonta International breakfast event was very successful, as was the Women in Public Sector Summit, held on Wednesday 10 March, both of these online events.

Many organisations took the opportunity to profile women in their organisations or launch initiatives to benefit women, for example, the Commission for Financial Capability (CFFC) launched a new course for women, Sorted Women. Organisations can arrange for the Sorted Women Workshop in their workplaces as a way to increase financial knowledge and capability.

Global Women NZ also launched a #DroptheMotherhoodPenalty campaign to address biases and barriers that may impact on working women. This campaign has actions that organisations can do to support women in the workplace, reduce bias and increase women in leadership roles. It draws on Ministry research from 2017 into parenthood and labour outcomes and the gender pay gap.

All women and girls are financially secure and can fully participate and thrive

Pay equity webinar

On 8 March 2021, the Ministry supported the Gender Pay Taskforce to present a webinar on the Equal Pay Act. The webinar explained in practical terms how the pay equity process works, including raising, assessing, bargaining, and settling a claim. Over 150 participants from public sector women's networks, unions, and other organisations viewed the webinar. Feedback was positive, with participants commenting that they had found the information easy to understand and useful. We will continue to work with the Gender Pay Taskforce to explore other similar webinars or other events to ensure women are aware of their options and rights in relation to pay equity.

MBIE's Bullying and Harassment at Work Issues Paper and consultations

The Ministry for Business, Innovation and Employment (MBIE) released its 'Bullying and harassment at work issues paper' in December 2020 and calls for submissions from the public close on 31 March 2021. MBIE officials held a consultation with women's groups on Friday 5 March 2021, which included NACEW members, and a representative from the National Council of Women. MBIE will use the consultation sessions to guide future policy development and potential changes to the health and safety at work and employment relations systems. We will ask NACEW members to provide you with advice on the paper at the next NACEW meeting on 25 May.

Economic harm and family violence

A Ministry official met with members of the Good Shepherd NZ to talk about its work on economic harm and abuse. Economic harm (often called financial or economic abuse) is a form of psychological abuse within the Family Violence Act. It involves behaviour that controls, restricts or removes access to money, economic resources, and/or participation in financial decisions. Good Shepherd NZ works with people, predominantly in the family violence and financial sectors, to improve responses to this issue. We will use this information in our work to look at the barriers violence creates for women in employment as part of your priority focus on preventing violence against women.

Voices of survivors of violence

As part of the Ministry work to explore how we can bring the voices of women directly into our work on family violence prevention, a Ministry official met with Deborah McKenzie from The Backbone Collective, a member of the Ministry's International Women's Caucus. This is a national coalition of survivors of Violence Against Women in Aotearoa New Zealand. The Backbone Collective has an online communication platform and runs surveys on how violence and abuse affects women, identifying where the system does and doesn't work for them, and where improvements can be made. The outcome of the meeting was a discussion on how this information, and the voices of women can be included in the Joint Venture's work to develop the All-of-Government response to family and sexual violence. This work contributes to your priority focus on preventing violence against women.

System leadership, impact, and reputation

Commission on the Status of Women (CSW65)

Work is progressing well towards the CSW65 events that will take place from 15 to 26 March 2021. The videos that you have provided of the National Statement and Ministerial Roundtable statement have been submitted to the CSW Secretariat. Other confirmed speakers in the Ministerial Roundtable session include: Australia's Gender Equality Ambassador (chairing the session), and Ministers from Colombia, Italy, Kenya, United Arab Emirates, Chile, Ireland, Tuvalu, South Africa, Japan, Kazakhstan, Luxembourg, Senegal, Iceland, and the State of Palestine.

Regarding NGO and civil society engagement, for the side event we are hosting on 15 March 2021, registrations have been received from women representing a wide range of organisations, including the National Council of Women, Rural Women New Zealand, Family Planning, Soroptimist International, the Global Goals Institute and several others. Virtual meetings have also been set up that will be used throughout the CSW period to keep NGO representatives informed of progress. NGOs can also use the virtual meetings to share their findings from any parallel events they may have attended.

Part 2: Operational matters

Security patch of IT infrastructure

The Ministry has patched its email servers following advice from the National Cyber Security Centre related to the management of cyber security threats. The threat was a critically rated Microsoft Exchange server (email) vulnerability that is impacting organisations worldwide. The Ministry continues to work closely with its information technology partners and other Government information technology advisors to review and address any cyber security threats that arise.
