## Mana Wāhine roopū update

### **Bereavement**

Manatū Wāhine whānau were sad to hear of the passing of Te Riria (Lydia) Proctor last week. Te Riria was one of the founding members of Te Ohu Whakatupu (previous Māori policy unit in Ministry for Women Affairs) where she worked as Communications Advisory Officer (with special responsibility for Pūtea Pounamu).

At the end of 2003, Te Riria (Lydia) Proctor retired from the Ministry having served wähine Māori through her role in the Ministry for 17 years. She was then, the only staff member left from the Te Ohu Whakatupu period. As the Ministry's Māori Communications and Liaison Officer, Te Riria Proctor had played an essential role throughout Te Ohu Whakatupu's existence in connecting the Ministry with Māori communities, and gathering information from Māori women to inform the Ministry's policy advice.

Flowers were sent to her whanau at her marae in Hastings. Moe mai ra e hine.

#### National Association of Women in Construction Excellence awards

On Wednesday 10 March 2021, the Ministry's Nominations Manager represented the Ministry as a judge for the National Association of Women in Construction New Zealand (NAWIC) Excellence awards. The awards event will be held in Auckland on 7 May 2021.

The awards recognise women in construction, and celebrate the talented women in this industry. The Nominations Manager was a judge for the Construction Administration Award, and spoke with women from across Aotearoa about their work in areas such as health and safety, building inspection, and project administration. It was truly inspiring to hear their stories and learn about the challenges they have overcome in their careers.

This work is a part of the ongoing relationship the Nominations Service has with NAWIC, which also includes identifying women in construction eligible for a New Zealand Honour.

Our research project with Motu, looking at the impacts of access to childcare and women's employment, will provide new data for this review. We will report on early findings in June 2021.

## System leadership, impact, and reputation

#### Communications - Report: Pacific women and men in business

On Tuesday 16 March 2021, Manatū Wāhine Ministry for Women and the Ministry for Pacific Peoples published, online, the report: *Pacific women and men in business*.

This report, supported by NACEW, provides data about the businesses owned in full, or in part, by Pacific people, and has the data broken down by income, educational qualifications, industry by region, business type, the number of employees, and age of the business. It is the first report to analyse Pacific-owned businesses and provides a baseline of data to measure against as Aotearoa New Zealand recovers from the effects of COVID-19.

The Ministry will continue to share this report with stakeholders to increase awareness of the characteristics of Pacific-owned businesses.

#### International - Commission on the Status of Women

The Commission on the Status of Women (CSW) fortnight is off to a good start; the video message that you provided for the Ministerial Roundtable on enabling women's participation in public life was well received, when it was played on 16 March 2021. We will advise you when the National Statement has been played.

Other CSW events that New Zealand has participated in to date include:

- Dr Nicola Ngawati, Director of the joint roopū spoke about women's leadership in response to the COVID-19 pandemic, the impacts for wāhine Māori, the Mana Wāhine Kaupapa Inquiry, and the COVID-19 Community Fund at a side event hosted by Canada;
- Alex Chadwick, Manager of the Gender Pay Taskforce, spoke about New Zealand's experience of implementing pay equity legislation at a Fair Pay Roundtable parallel event;
- Craig Hawke, Head of the Permanent Mission to the United Nations, attended a "Group of Friends" event on eliminating gender-based violence.

In addition, a number of New Zealand civil society representatives are presenting at a diverse range of parallel events covering topics such as women's participation in sport, the effects of incarceration on women, and gender equity in the judiciary. We understand that Golriz Gharaman, MP, will be speaking at a side event hosted by Japan, on the topic of women leaders in politics.
