## Part 1: Current priority outcome areas

### Women's Employment Action Plan (WEAP) update

Development of the WEAP is progressing well, being informed by a number of productive stakeholder meetings discussing a range of perspectives.

#### Meetings included:

- On 3 August 2021, the National Advisory Council on the Employment of Women (NACEW) met with its partners (YWCA, National Women's Council, Rural Women, Māori Women's Welfare League and PACIFICA) as well as Global Women and the Iti Rearea Collective (migrant women). Issues covered included the gender pay gap, pay equity, supporting women in business, access to childcare, and the need for on-the-ground action for wāhine Māori and Pacific women in particular.
- Bernadette Pereira hosted two focus group meetings in South Auckland with young Pacific women.
- Interviews with young mothers were completed in Gisborne on 29 July.

#### Upcoming meetings include:

- Māmā Moving Mountains, next week tbc.
- International Women's Caucus, 10 August 2021.

We will share themes from these meetings with you at our next officials meeting.

We have already provided the Employment, Education and Training (EET) Secretariat with a preliminary draft of the WEAP for their meeting on Wednesday 3 August 2021, to be discussed further at the EET CE meeting next week (week commencing 9 August). Once we have collated items and reviewed the plan, we will provide you with a copy for your consideration.

### Mana Wāhine Roopū update

#### Research

The Joint Roopū has been working with the Crown Law Office, with the assistance of the National Library of New Zealand and the Alexander Turnbull Library, on the identification of archival material that may be relevant to the Tūāpapa hearings. The Joint Roopū recently filed copies of the resulting bibliographies with the Waitangi Tribunal.

The Joint Roopū is waiting for six draft research briefs from the Waitangi Tribunal on their planned research reports. We will then discuss these briefs with relevant agencies as part of a feedback process.

This week, Joint Roopū representatives will meet with Crown Law and Stats NZ to discuss next steps, and coordination of the Crown Statistics Project. Key issues to discuss relate to the clarification of requests for data and statistics that are expected to support wider research projects as part of the Mana Wāhine Kaupapa Inquiry.

### All women and girls are financially secure and can fully participate and thrive

#### Release of Household Labour Force data

New employment statistics show significant drops for both unemployment and underutilisation rates, driven primarily by employment gains for men. Unemployment and underutilisation rates now match the pre-COVID levels, with previously existing disparities for women, especially in terms of underutilisation and underemployment.

The statistics were released on 4 August 2021, and comprise the June 2021 quarter of Stats NZ's Household Labour Force Survey (HLFS). We note that the updated data on women's and men's median earnings will be released on 18 August 2021, including an updated national gender pay gap (GPG) for 2021.

# International Women's Caucus Aotearoa meeting, 10 August 2021, Onehunga Community Centre, Auckland

The Whakatau Pacific Women's Watch will host the quarterly meeting of the International Women's Caucus Aotearoa. Manatū Wāhine will be sending three representatives: Kellie Coombes (Secretary for Women), Rebecca Barnes (Director, International Policy), and Anna Chapman (Policy Analyst). Items for discussion include an update on the development of Women's Employment Action Plan and the Long-Term Insights Briefing.

### APEC update

Planning continues for the second APEC Policy Partnership on Women and the Economy meeting for 2021, which leads into the Ministerial-level Women and the Economy Forum (WEF) in September. The Policy Partnership meeting will be held over three sessions on the afternoons of 17, 19 and 21 August 2021. Opening speakers for each session will be Julia Torreblanca, Chair of APEC Business Advisory Council's Inclusion Working Group; Traci Houpapa; and Jatuporn Rohanaparnich from Thailand (APEC hosts for 2022). Session 1 will cover administrative updates; Session 2 will be an interactive policy dialogue with presentations followed by breakout room discussions; Session 3 will see presentations from chairs of other APEC working groups on cross cutting issues, followed by a handover to Thailand for 2022.

Invitations to the September WEF have been sent, and the agenda is close to being finalised. The Ministry hosted a drafting session with APEC economies on 4 August 2021 to progress the Women and the Economy Forum statement. As previously advised, we have been leading the negotiation process for the WEF statement, the final text of which will be adopted by Ministers at the WEF. The statement is ambitious in tone and prioritises the implementation of the La Serena Roadmap for Women and Inclusive Growth and gender responsive policies for recovery from the COVID-19 pandemic. It calls for measures to advance gender equality and women's economic empowerment, including through measures to address gender pay gaps and occupational segregation, and promote the transition of women to the formal economy. Other areas of action highlighted in the statement include:

- enabling women's representation in trade
- addressing the disproportionate share of care work undertaken by women and girls
- promoting equal access to digital skill training and financial literacy
- eliminating all forms of gender-based violence, abuse and harassment.

We will keep you updated through the weekly report and provide the statement in full alongside a briefing on the WEF in due course.


