Women's Employment Action Plan (WEAP) update

WEAP and Cabinet paper progress

The Employment, Education and Training (EET) Chief Executives this week discussed the WEAP draft papers, including amendments based on Deputy Chief Executives' comments. Engagement continues with agencies that are leading Plans and with delivery agencies that are expected to be involved in resulting actions. We also had an additional session with the National Advisory Council on the Employment of Women (NACEW) on 8 September 2021. We will send the WEAP papers and draft Cabinet paper to the EET Ministers group for discussion on 23 September 2021, and we will provide you with talking points for this meeting. Mana Wāhine Roopū update

Joint Research Committee (JRC)

The Roopū Director is commissioning a recommended wāhine Māori academic to moderate the JRC draft research briefs before they go out for tender. This is good progress, with the JRC needing to establish a tendering process and claimant representatives to carry out further consultation with the claimant community.

On 3 September 2021 Kerri Nuku (Kaiwhakahaere (Director) and President of the New Zealand Nurses Organisation) was awarded the Human Rights and Nursing Award by the International Care Ethics (ICE) Observatory at the University of Surrey, United Kingdom. Ms Nuku is another example of a high-profile claimant involved in the Mana Wāhine Kaupapa Inquiry, presenting evidence on behalf of Māori nurses at the second tūāpapa hearing in Ngāruawāhia (24–26 February 2021). Following receipt of the award, Ms Nuku noted that the political voices of Māori nurses have often been overshadowed by men, or male Māori, in ways that reduce Māori nurse advocacy, authority and tino rangatiratanga.
