Current priority outcome areas

Women's Employment Action Plan (WEAP) update

We have revised the WEAP based on your comments and it will now be provided to the Employment, Education and Training (EET) Ministers on 23 September 2021 for their consideration. We have also worked with:

- the Tertiary Education Commission to strengthen current actions for women in careers and study
- the Ministry for Social Development on actions on the Childcare Support review
- the Ministry for Business, Innovation and Employment on actions on pay transparency and harassment and bullying. We have also discussed how to align the WEAP with other action plans, in particular the Māori Employment Action Plan which is due to go to EET Deputy Chief Executives at the end of September 2021.

You are attending the second National Advisory Council on the Employment of Women (NACEW) and partner meeting via Zoom on 22 September 2021 from 11.30am to 12.00pm. We have asked participants to focus on identifying key actions for women's employment in their sector or within the population groups that they represent. We are providing you with a memo and talking points for this meeting. The invited partner organisations are: Māori Women's Welfare League, P.A.C.I.F.I.C.A., YWCA, National Council of Women, Rural Women, Global Women, Iti Rearea Collective, Māori Women's Development Inc., and the Equal Employment Opportunities (EEO) Commissioner Saunoamaali'i Dr Karanina Sumeo.

Mana Wāhine Roopū update

(some content shared with Minister Jackson following consultation with Te Puni Kōkiri)

Joint Research Committee (JRC)

The Roopū Director attended the JRC meeting on 14 September 2021. Progress on the draft research briefs was discussed. All the research briefs need more work by the drafters before they are discussed with claimants at a claimant-only hui on 28 September 2021. The JRC approved the Roopū Director to proceed to commission a recommended wāhine Māori academic to moderate the briefs before they go out for tender. Progress was also made on the development of a finance protocol by the JRC Treasurer (Tamaki Legal) for the eventual contracting of researchers through Manatū Wāhine.

Tūāpapa hearings 4-6 update

During the JRC meeting, claimant coordinating counsel indicated that the ongoing lockdown of Tāmaki Makaurau Auckland in Level 4 is affecting the ability of three legal firms to progress the preparation of claimants briefs of evidence before the next hearing (22–26 November 2021 at Te Manuka Tutahi Marae, Whakatāne). This relates to the requirement by some witnesses for their evidence to be recorded kanohi ki te kanohi (face to face). We understand the Mana Wāhine Kaupapa Inquiry panel will meet at some point to discuss the levels of uncertainty relating to the

Covid-19 Delta outbreak and future hearing dates. We will continue to keep you updated as part of your consideration of attendance at future tūāpapa hearings.



Reopening of COVID-19 Community Fund

On 8 September 2021 Cabinet agreed to reopen the Covid-19 Community Fund (the Fund). In our on 9 September 2021 briefing to you regarding the Fund (MW 21-22 0087), we indicated we would conduct a rapid operational review of the 2020 Fund once Cabinet had approved the 2021 Fund. We have reviewed our processes in light of the previous Fund in advance of applications opening on 17 September 2021. Applications will close on 1 October 2021. We will advise you on our proposed assessment process and panel members before the application period closes. We intend to invite one panel member from last year's process for consistency and one further panel member with experience and background in Pacific communities. The Secretary for Women will approach possible panel members in the coming week, to seek their agreement to participate. We intend to convene the panel in mid-October.

System leadership

Long-term insights briefing (LTIB)

Officials have been working alongside other LTIB working group members (Ministry of Education. Ministry of Social Development, Ministry for Business, Innovation and Employment) to develop papers for discussion at the Employment, Education and Training (EET) Deputy Chief Executives (DCEs) meeting on 17 September 2021. The papers provide a proposed Briefing outline in addition to several questions relating to the scope of the Briefing. The LTIB working group will continue to provide a series of short papers to EET DCEs for discussion, as the content of the Briefing is developed. This will enable EET DCEs to provide clear steers about the content during the drafting process.

Summary of public consultation

Consultation on the proposed Briefing topic was carried out over July-August 2021, noting that the Ministry joined the EET LTIB partnership in late August 2021. This included a publicly available online survey through which 155 people provided online submissions. There was strong interest and support for the subject of youth at risk of limited employment (95 per cent of online respondents said it was a worthwhile subject to investigate). Respondents also largely agreed with the proposed scope (62 percent of online respondents indicated they either agreed or partially agreed with the scope). Alternate scope suggestions tended to concern mental health, housing, physical health or wellbeing. There was also broad agreement with the proposed focus areas, making up 74 percent of online responses. Alternate focus areas that were proposed included mental health, neurodiversity, careers support in schools and study to work transitions.

Next steps

At this stage, key milestones for the development of the LTIB include:

- September 2021 outline LTIB agreed by EET DCEs, additional evidence and analysis • commissioned
- December 2021 draft LTIB agreed by EET DCEs pending placeholders/further changes to • be incorporated over the summer in the second se
- Late January 2022 draft LTIB agreed by EET CEs •
- February March 2022 public consultation on a draft LTIB •
- April-May 2022 finalise LTIB
- June 2022 present LTIB to relevant Ministers.
