## **Current priority outcome areas**

### Women's Employment Action Plan (WEAP) update

Once you have discussed the Plan at the Employment, Education and Training (EET) Ministers group on 23 September 2021, we will finalise the draft Cabinet paper for your agreement for the Ministry to send it for wider ministerial and agency consultation (30 September to 13 October 2021). We have received reports about the social impact of COVID-19 on women from the Ministries of Education, Health, and Housing and Urban Development and the Joint Venture on Family Violence and Sexual Violence for inclusion in the Cabinet paper. The Cabinet paper will be lodged on 20 October 2021 for the Social Wellbeing Cabinet Committee meeting on 27 October 2021.

National Advisory Council on the Employment of Women (NACEW) and its partner agencies met on 22 September 2021 to discuss the Plan. This was their second meeting about the Plan, and they agreed that the three key themes (Women are financially secure, the labour market is inclusive; Women are supported to meet their paid and unpaid work commitments without incurring penalties) would capture employment actions for women. The group identified many of the topics already noted in the draft action table e.g.:

- gender pay gap (public and private sectors)
- pay transparency
- bullying and harassment in the workplace
- supporting women in business and entrepreneurship
- increase in parental leave provisions,
- recognition of women's unpaid work (in particular in cultural settings)
- · access to affordable childcare.

The group also identified other topics such as the increased digital divide that COVID-19 has highlighted and the need for practical on the ground actions to support women, in particular for Wāhine Māori, Pacific and ethnic women. The next stage is to develop an engagement framework that NACEW and its partner agencies can use to reach out to the women they support in the community.

## Mana Wāhine Roopū update

#### Coordination across agencies

This week the Joint Roopū held a preparatory hui for our next Interdepartmental Working Group on 30 September 2021. This will enable us to update wider agencies on our combined work developing the All-of-Government Framework and our current focus to stand up a Crown Research Working Group. The latter will inform our wider perspective on the Joint Research Committee and enable insights on the research landscape across agencies.

#### Joint Research Committee (JRC)

As part of our Co-Secretariat role of the JRC we are working with members to set the work programme for the JRC for the next four to six months. JRC claimant members are focused on the finalisation of the draft research briefs, the Joint Roopū commissioning of researchers and their own preparation for the 4th tūāpapa hearing on 22–26 November in Whakatāne. JRC members are also engaged on the related takapou whāriki process (video records of some wāhine Māori korero). On the latter we and the JRC are awaiting further information from the Waitangi Tribunal on next steps.
