Women's Employment Action Plan (WEAP) update

We are currently addressing comments received from the Ministerial and agency consultation on the draft WEAP. The Cabinet paper will be lodged on 20 October 2021 prior to being considered by the Social Wellbeing Cabinet Committee on 27 October 2021. We are currently developing a WEAP stakeholder engagement plan, and have held meetings with the action plan lead agencies to consider how actions align for women (Māori Employment Action Plan – Ministry of Business, Innovation and Employment, Pacific Peoples Employment Action Plan – Ministry for Pacific Peoples, Former Refugees, Recent Migrants and Ethnic Communities Employment Action Plan – Ministry of Ethnic communities, and Older Workers Employment Action Plan – Ministry of Social Development).

Mana Wāhine Roopū update

Mana Wāhine Kaupapa Inquiry

An article in the October 2021 New Zealand Public Service Association (PSA) Working Life Journal details the launch of a PSA Mana Wāhine campaign focusing on systemic racism and bias in the workplace. The campaign responds to the findings of a report the PSA commissioned in early 2020 to analyse a survey of more than 900 wāhine Māori PSA members. A more detailed campaign plan will be discussed by PSA members at a hui in November 2021. Key issues highlighted by the report include conscious and unconscious bias, educational disadvantages affecting employment and pay opportunities and a persistent pay gap for wāhine Māori. Te Rūnanga o Ngā Toa Āwhina (Māori members of PSA), who are claimants to the Inquiry, stated in the media that this campaign will support their claims. These include allegations that the Crown failed to: provide education that prepares wāhine Māori for employment; eliminate bias and discrimination in the workplace; give appropriate status to tikanga Māori and Mana Wāhine; and ensure fair working conditions and remuneration.

Research

On 8 October 2021, the co-chairs of the Interdepartmental Steering Group agreed to establish a Crown Research Working Group (CRWG). The creation of a dedicated cross-agency research group is a big milestone for the Joint Roopū as the Inquiry heads into the research phase. The CRWG's key functions are to collaborate with the Waitangi Tribunal and the Joint Research Committee to determine and make available data and research held by partner agencies, to facilitate disclosure of documents/discovery process, and to coordinate the production of Crown research and evidence across agencies for the Inquiry. The group will convene its first hui in the next fortnight. The Joint Roopū will provide you and Minister Jackson with an overview of all the research work planned or underway in a memo on 11 November 2022.

Judicial Conference

The Waitangi Tribunal has postponed the next Judicial Conference planned for 15 October 2021 until 21 October 2021. The Joint Roopū is working with Crown Law Office on a Memorandum of Counsel for the Crown (to be filed before the Judicial Conference) that outlines the Crown's position on the Takapou Whāriki process and provides an update on the Crown statistics project. The Joint Roopū will provide you and Minister Jackson with a memo reporting on the outcomes of the Judicial Conference on 1 November 2021.

We have sent the 287 applications for COVID-19 Community Funding, seeking a total of \$9.6 million, to the Assessment Panel to review. Family Violence and Sexual Violence Strategy and Action Plan

We have worked with the Joint Venture Business Unit (JVBU) to include an action for wāhine Māori. This will be a tuakana-teina based initiative focusing on developing and nurturing emerging wāhine Māori leaders in the family violence and sexual violence space. The Ministry will lead the policy development and engagement with wāhine Māori leaders and partner agencies to inform design scope for the tuakana-teina based initiative and its testing. Once completed we will identify the resources required to implement the tuakana-teina based initiative. We have also provided a gender analysis of the action plan which identified questions that the JVBU will need to answer so that women can 'see' how the family violence and sexual violence actions will support them.

Pacific Women Leaders Meeting (PWLM)

On 15 October 2021 the Ministry will attend the Fourth Pacific Women Leaders' Meeting, chaired jointly by Australian Minister for Foreign Affairs and Minister for Women Marise Payne, and Samoa's Minister of Finance Mulipola Anarosa Ale Molioo. This series of meetings was initiated in 2020 by Australia to discuss responses to COVID-19 across the region. The agenda covers: gender equality in a COVID-19 context; women's leadership; and planning for the Pacific Islands Forum Women Leaders' Meeting in November 2021. S 6(a)
