Current priority outcome areas

Women's Employment Action Plan (WEAP) update

The draft Cabinet paper and WEAP has been sent for wider Ministerial and agency consultation. We included a high-level implementation table with the Cabinet paper. Comments are due by 22 April 2022. Following this, we will finalise the Cabinet paper and WEAP for your approval to lodge for discussion at the Social Wellbeing Cabinet Committee on 4 May 2022.

We have also provided you with a briefing outlining ideas for the launch of the WEAP in mid-tolate June in South Auckland. Participants would include with women who participated in the engagement on the Action Plan, NACEW members, and partner organisations. NACEW member Bernadette Pereira has agreed to help us arrange the event.

Joint Venture on Family Violence and Sexual Violence

Ministry officials attended the Joint Venture on Family Violence and Sexual Violence DCE meeting this week where we discussed the implementation of Te Aorerekura actions, new monthly reporting on progress, and establishing the Interdepartmental Executive Board and the associated operating model which is coming into effect on 1 July 2022.

We reported at this meeting that we are starting work on Action 4: Wāhine Māori leadership succession and would be discussing stakeholder engagement with the JV Chief Māori Advisors.

Mana Wāhine Roopū update

Mana Wāhine Kaupapa Inquiry

On 7 April 2022 the Joint Roopū chaired the inter-agency Crown Research Working Group meeting. The Ministry for Social Development (MSD) provided a presentation on its response – to both support the Mana Wāhine work programme and claimants' and researchers' needs to access existing research.

An annotated bibliography is being created, commencing in 1938 (when the Social Security Act was passed), up until 2022. When completed, this will be published as an online artefact on MSD's website for public access. This extensive resource looks at all the literature and documents held, generated, or commissioned by MSD and earlier iterations and bodies such as Department of Social Welfare, and Child Youth and Family, and the Families Commission. MSD's primary focus area will be on the systemic discrimination and disparities impacting outcomes and well-being for wāhine Māori.

Other news

Merewaakana Kingi (Ngāti Awa, Ngaitai), has been appointed as a Future Director on the board of ASB Bank. Merewaakana is the Acting Chief Financial Officer of Ngāti Awa Group Holdings Limited and has worked in the Corporate and Māori sectors for large organisations including

Deloitte, BNZ, The Royal Bank of Scotland, Morgan Stanley, and Air New Zealand. Merewaakana is also a Chartered Accountant, a founding member of the National Māori Accountants Network, and an Independent Director on the New Zealand Māori Rugby Board.

The 2021 Te Waka Toi Awards were announced on 9 April 2022 (after an initial COVID-related delay). Nine of the fourteen Māori artists recognised at these awards are wāhine Maori, including Dame Hinewehi Mohi (Ngāti Kahungunu, Tūhoe – Singer, Songwriter, Music Producer) who was recognised for her outstanding work strengthening Te Reo Rangatira.

Kiri Tahana (Ngāti Pikiao, Ngāti Makino and Tapuika - Te Arawa), a Rotorua barrister and solicitor, has been appointed a Judge of the High Court, Attorney-General David Parker announced on 8 April 2022. Justice Tahana has extensive experience in commercial and corporate law and litigation, along with considerable expertise advising on matters relating to te Tiriti o Waitangi.

System leadership - events and communications

Pay transparency

We are continuing to work with MBIE to provide you with a paper on pay transparency by 28 April 2022 for your discussion with Minister Wood on 2 May 2022. We have been speaking with other government agencies including Te Kawa Mataaho Public Service Commission about their work in this area to inform a potential education and information campaign. Kellie Coombes also met with senior MBIE officials on 14 April to discuss the approach from both agencies on pay transparency.

Immigration New Zealand (INZ) family violence visas

We met with INZ officials to discuss the process they use in cases of women applying for the family violence visas. INZ explained that only partners of New Zealand residents can access the "victims of family violence" visas; this does not include partners of temporary visa holders who are on a work visa or a student/study visa. They noted that when family violence has been proved, the applicant can access (for an indefinite time period) a victim of family violence visa and can apply for residency if they can show that it is not feasible for them to return to their home country. There will be a review of this process 9(2)(f)(iv)
