Mana Wāhine Roopū update

Mana Wāhine Kaupapa Inquiry

Dame Aroha Reriti-Crofts (Ngāi Tūāhuriri, Ngāi Tahu) passed away this week. She was a former president of the Māori Women's Welfare League, original WAI 381 claimant in the Mana Wāhine Kaupapa Inquiry, teacher, kapa haka advocate, and community leader. Dame Reriti-Crofts was farewelled at her marae near Kaiapoi.

We are continuing to progress the legal discovery request underway in the Justice Kaupapa Inquiry mini inquiry. Crown Law Office advised us on 24 May 2022 the Waitangi Tribunal has decided to vacate the first hearing week from 13-17 June. We are expecting the Tribunal to issue new dates in forthcoming Memorandum Directions and will continue to keep you updated.

On 24 May 2022 we received a copy of the draft Tūāpapa hearing 4 timetable which we will forward to your office, should you be able to attend on 11 July 2022.

Other news

Two kōhine Māori are amongst this year's winners of the Te Ara a Kupe Beaton Scholarship, which aims to support tauira (students) Māori to gain entrance into the world's most competitive tertiary education providers. Rhiannon Kapa (Lytton High head prefect) aims to use the scholarship to become a dermatologist or clinical surgeon. Amaia Watson (Napier Girls' High School head prefect) aims to complete degrees in Law and Environmental Science.

System leadership - national

Ministry of Foreign Affairs and Trade (MFAT) officials have drafted a short joint briefing on the recently completed OECD Trade and Gender review of New Zealand (led by MFAT), alongside Manatū Wāhine-led research on New Zealand Women in Trade, carried out by BERL. This briefing will go to the Minister of Foreign Affairs and be referred for noting to you, the Minister for Trade and Export Growth, and the Parliamentary Under-Secretary for Trade and Export Growth. The reports provide complementary views on different aspects of women's engagement in exporting, with recommendations for policy settings to better support women entrepreneurs. We will provide further information on potential communications and a joint launch of the reports, in collaboration with MFAT.

System leadership – international

Australian Election

Following the Australian Federal election Prime Minister-elect Anthony Albanese has said his government would make "equal opportunity for women a national economic and social priority".

The new Minister for Women, Katy Gallagher, who is also Minister for Finance and Attorney-General, has been a Senator for Australian Capital Territory (ACT) since 2019. Prior to entering politics, she was a social worker, and later a union organiser for the Community and Public Sector Union. We will draft a congratulatory letter on your behalf to go to Minister Gallagher.

Linda Burney, a member of the Wiradjuri Nation, has been appointed as Australia's first female Minister for Indigenous Australians. S 6(a)
