Current priority outcome areas

Te Mahere Whai Mahi Wāhine Women's Employment Action Plan (WEAP) update

The launch of the Women's Employment Action Plan this week in South Auckland was very successful, with over 50 women present. Inspirational stories were shared by the women who participated in the plan about what changes are needed to support women's employment.

We are now developing implementation templates to workshop with agency leads and developing a dashboard to measure progress (using the red, amber, green approach). We are also participating in a workshop led by the Ministry for Ethnic Communities on the actions we are leading with them, as part of their employment action plan.

We will provide you with an implementation package by the end of August, once we have completed this work.

Mana Wāhine Roopū update

Mana Wāhine Kaupapa Inquiry

The roopū is in the final stages of our preparations for tūāpapa hearing four and our memo to support your attendance on 11 July 2022 will be with you this week. The roopū is also supporting the Chair of the Joint Research Committee (JRC) in her preparations for a hui between the claimant representatives on the JRC and the claimant community in Whakatāne.

On 15 June 2022, the Tribunal received a memorandum on behalf of claimant coordinating counsel which attached the witness list for tūāpapa hearing five. Judge Reeves has agreed to their request for a finalised witness list for tūāpapa hearing five, to be provided by 29 June 2022.

Other news

The director for Māori, Pacific and Equity at the University of Canterbury Sasha McMeeking (Kāi Tahu) has announced a new scholarship which aims to "change the story of who gets to university". For the next two years, 150 places will be offered each year to tauira from low decile schools in Te Waipounamu.

System leadership – national

Ministry of Health Women's Health Strategy

We have met with Ministry of Health officials about supporting their work to develop a Women's Health Strategy and will provide policy support to develop the high level discussion document and assist with the proposed engagement. s 9(2)(f)(iv)

NZCTU nomination for NACEW

The New Zealand Council of Trade Unions (NZCTU) has one representative on the National Advisory Council on the Employment of Women (NACEW). The previous representative, Erin Polaczuk, resigned from her role at the Public Service Association and is therefore no longer eligible to represent NZCTU. NZCTU has nominated Melissa Ansell-Bridges (NZCTU National Secretary) as its new representative. Melissa attended the last NACEW meeting in an acting

capacity and will attend the NACEW meeting on 30 June 2022. NACEW members are appointed by you as Minister for Women, but appointments need to be confirmed by the Cabinet Appointments and Honours Committee (APH). The Ministry will begin the APH appointment process for the NZCTU representative.

System leadership – international

EU-NZ Free Trade Agreement (FTA)

We have been working closely with Ministry of Foreign Affairs and Trade (MFAT) officials in the final stages of negotiation of the EU-NZ FTA. Manatū Wāhine and MFAT very much appreciated your assistance with quickly turning around updates to the negotiating mandate over the past week. Overnight on Monday 28 June, negotiators were able to reach agreement on the gender equality elements of the text, drawing to a successful close this section of the negotiations. Work continues towards concluding more challenging sections of the text, ahead of the Prime Minister's visit to Brussels at the end of the week.
