Pay Transparency

The Ministry, along with MBIE officials, met with NACEW members and partners on Wednesday 7 December to discuss the collective input and approach toward a Pay Transparency system.

A comprehensive and robust discussion was chaired by Traci Houpapa and agreement from the group was shared by all partners to facilitate and endorse engagement with their respective networks and communities.

System leadership - national

Gender budgeting

The Ministry has delivered five Gender Budgeting training workshops with agencies. A total of 34 staff from 10 Government agencies participated, learning about what gender budgeting is, the findings of the Budget 2022 pilot, and how to complete the exercise for Budget 23.

We have received positive feedback from agencies who found the sessions and support helpful and informative, and remarked that the exercise encouraged them to dig out gender-disaggregated data that they would not have otherwise considered in the initiative's development. System leadership – international

Responding to the Convention of the Rights of People with Disabilities (CRPD) recommendations

On Tuesday 5 December, you attended the Ministerial Leadership Group on Disability Issues meeting with the Independent Monitoring Mechanism (the Human Rights Commission, the Ombudsman and the Disabled People's Organisations Coalition) and your Ministerial colleagues.

Manatū Wāhine is discussing our response on the relevant CRPD committee recommendations with Whaikaha – Ministry of Disabled People. Draft responses are due to Whaikaha mid-December.

Iran: Human Rights Councils adopts resolution co-sponsored by New Zealand to establish a fact-finding mission

The Ministry has provided advice to MFAT and Ministers on actions and options to condemn the deteriorating human rights situation in Iran following the death of Mahsa Amini.

We helped draft and co-sponsor a United Nations resolution seeking to "establish a fact-finding mission to thoroughly and independently investigate alleged human rights violations in the Islamic Republic of Iran related to the protests that began on 16 September 2022, especially with respect to women and children."

The Human Rights Council adopted the resolution on 24 November 2022. s 6(a), s 9(2)(g)(i)
