#### System leadership - national

#### \$500,000 Puawānanga Community Fund

The Minister for Sport and Recreation has approved \$6 million to support government leverage and legacy activity related to the FIFA Women's World Cup. The Ministry of Business, Innovation and Employment (MBIE) is administering this funding through the *Puawānanga Leverage and Legacy Fund*. The Fund aims to maximize the benefits of FIFA Women's World Cup 2023 for Aotearoa New Zealand by funding projects led by Crown agencies. MBIE sought applications from government agencies for activities that will improve the wellbeing of women and girls. The activities are intended to be wider than sports.

We submitted a bid to MBIE for \$500,000 for a Puawānanga Community Fund, which has been approved. Modelled off the COVID-19 Community Fund, this contestable Fund will support not-for-profit community organisations to offer programmes and initiatives for women and girls who face intersecting barriers to improve their participation in sports, active recreation, and wellbeing activities. We will invite applications from community organisations for between \$5,000 to \$20,000 for two kinds of activities:

- a. Access to existing sports and wellbeing activities: many community organisations support families with, among other things, the costs of sports fees, uniforms, and equipment, or cultural activities. A community organisation we spoke to when preparing our proposal told us that the activities their girls want to participate in (such as dance and gymnastics) are often more expensive than the ones their boys tend to favour. So funding specifically for girls' activities would make a big difference to their community.
- b. Tailored programmes: many community organisations run programmes tailored for women and girls who are not well-served by mainstream sports, arts and recreational activities. These grants would support workshops, classes or activities designed for, for example, disabled women and girls, or women and girls from under-served ethnic communities. Organisations that serve rural communities who do not have much choice in sports, active recreation, arts and cultural activities may also seek these grants.

We have asked MBIE whether announcements about the Puawānanga Community Fund should come from you or the Minister for Sport and Recreation, or whether they should be joint. We will be in touch with your office in due course.

#### System leadership - international

#### 67th Session of the UN Commission on the Status of Women

The United Nations (UN) Commission on the Status of Women (CSW) is the global policy making body exclusively dedicated to gender equality and the advancement of women, running for two weeks annually in March. CSW67 is taking place in New York March 6-17th.

The priority theme for CSW67 is "Innovation and technological change, and education in the digital age for achieving gender equality and the empowerment of all women and girls." New Zealand will be represented by Secretary for Women Kellie Coombes and New Zealand's Permanent Representative to the UN, Carolyn Schwalger. Your pre-recorded delivery of the National Statement will be delivered in the General Discussion session during the first week. While in New York, officials will undertake bilateral meetings with counterparts, attend side events,

and liaise with NGO stakeholders throughout the session and in particular throughout negotiation of the Agreed Conclusions document. We will give you an update on key meetings and developments following the sessions conclusion.

#### **International Women's Day**

This year Mānatu Wāhine is holding an online series for International Women's Day (IWD) that combines the following themes:

- Embrace Equity (global IWD theme)
- DigitALL: Innovation and technology for gender equality (UN Women).

At the same time, we will use IWD to celebrate all women across Aotearoa New Zealand, acknowledging those particularly affected by Cyclone Gabrielle.

As the sixty-seventh session of the Commission on the Status of Women (CSW67) is taking place over the same period, we have also taken the opportunity to align our campaign with the CSW's theme of "Innovation and technological change, and education in the digital age for achieving gender equality and the empowerment of all women and girls."

#### Communications approach

Our online series will focus on driving digital equity and empowerment for women. We will celebrate success, highlight progress, call out disparity and provide informative resources via our social media channels.

Through the themes of digital, innovation and technology, we want to embrace the power of technology and digital innovation to empower all women and girls across Aotearoa.

Through a series of engaging content, we will share inspiring stories of women who are breaking barriers and embracing innovation to create a more equal world, alongside tools and resources to support safety online.

#### APEC Project "COVID-19 Indigenous and Diverse Women-Led MSME Responses"

This project has collected the voices of nine indigenous women who lead micro-small enterprise businesses and their experiences as businesswomen during the pandemic and some of the responses developed by different APEC economies. The stories told continue a narrative of women as leaders in their businesses, their communities and tribal organisations, and the centrality of family and community. They also report that too often COVID responses did not hit the mark, they were too bureaucratic and not fit for *their* purposes. A key part of the project was a commitment to publish the case studies in booklet form for these women and their communities where poor digital connectivity continues to be an issue of concern.

A copy of the booklet will be sent to your office for your perusal. Once the online version is published by the APEC Policy Management Unit in Singapore, the Ministry will proceed to publish through its website.
