#### **Engagements**

NACEW held two online meetings on 13 March 2023:

- NACEW talked with their partner organisations about the impact of the cyclone on flooding on women, implementation of *Te Mahere Whai Mahi Wāhine*, and pay transparency. The meeting was attended by YWCA, P.A.C.I.F.I.C.A, Iti Rearea Collective, National Council of Women, Rural Women, Shama Ethnic Women's Trust, and the Human Rights Commission, with apologies from the Māori Women's Welfare League, Māori Women's Development Inc, and Global Women.
- Manatū Wāhine, MBIE and NACEW met to discuss their role as the pay transparency advisory group, \$ 9(2)(f)(iv)

#### National Careers System Strategy

We provided feedback on the draft National Careers System Strategy (NCSS). The proposed strategy, under the development leadership of the Tertiary Education Commission, is an update to the current strategy.

We asked that women be specifically included in the priority groups. Women have different labour market characteristics than men and have unique needs across the course of their careers. There is intersectionality across women and the priority groups specifically identified: Māori, Pacific peoples, disabled people, and youth. Including women gives acknowledgement to the unique situation women in these groups face. The strategy also needs to acknowledge the impact of unconscious stereotypes on children throughout their schooling and in their career choices and address ways to minimise this.

The revised NCSS should strive to ensure that all people are treated equally, regardless of gender or ethnicity. We asked that "without bias" be added to the principle, Te Kounga | Quality, and as a recommendation within the Focus Area – Grow Quality Careers Support.

# Ara Poutama Aotearoa Department of Corrections, Reference Group meeting: Wāhine – E rere ana ki te pae hou Women's Strategy 2021 - 2025

We attended a reference group meeting on 27 February for the *Wāhine – E rere ana ki te pae hou Women's Strategy 2021 – 2025*, and discussed progress on the project: *Learning and Development Pathway and Support for Custodial Staff working in Women's Prisons*.

Interviews have been completed with around 120 custodial staff, other prison and national staff, and 16 women in prisons via the wāhine panels. They are now preparing the final report for approval to proceed to the Development Stage, looking to recruit further resourcing and connecting with other pilots across Corrections.

#### **Driver Licence Improvement Programme**

We participated in the second round of engagement sessions for the Driver Licence Improvement Programme, which discussed challenges to accessing driver's licences. Waka Kotahi is consulting widely to ensure all voices are heard.

The paper outlining the recommended direction for the future driver licence system is due to Ministers mid-Year.

#### System leadership – national

#### **International Women's Day**

Wednesday 8 March was International Women's Day 2023 with a range of events around New Zealand marking the occasion. This included Zonta Wellington's parliamentary breakfast which was attended by Manatū Wāhine and a range of women's organisations and stakeholders.

Since 1 March, we have shared a social media series across our four channels – Facebook, Instagram, Twitter, and Linkedin – around International Women's Day following the "DigitALL" theme set out by UN Women Asia Pacific. This series has included information on online gender-based violence and how to keep safe online, and sharing stats and profiling the innovative women and organisations that support women in the NZ tech industry.

We have also shared updates from the CSW67 delegation as this has the technology connection through the CSW67 priority theme, and we have profiled the NGO delegate – Norie Ape – as part of the women in tech series.

Each of our channels have seen a doubling in engagement and visitors to our pages during this campaign period as well as new followers. The overall response to the content was positive across all channels, particularly posts which celebrated IWD (<a href="https://bit.ly/3TbHLru">https://bit.ly/3TbHLru</a>) and the profiles of wāhine in STEM (<a href="https://bit.ly/3FkMbgk">https://bit.ly/3FkMbgk</a>).

International Women's Day 2023 marked the beginning of our commemorations for 130 years of women's suffrage in New Zealand, and we will be sharing more updates (and providing a fulsome memo on Suffrage 130 opportunities) shortly.

#### Women in Exporting event – Thursday, 4 May 2023, 9 – 10.00am

#### System leadership - international

#### 67th Session of the UN Commission on the Status of Women (CSW67)

The 67<sup>th</sup> Session of the UN Commission on the Status of Women (CSW67) took place between 6 - 17 March 2023.

You participated via pre-recorded statements for the National Statement, NGO Breakfast, and the Canada side-event on education in the digital age.

Kellie Coombes, Secretary for Women and Chief Executive of Manatū Wāhine, spoke at the Ministerial Roundtable event, and the delegation attended side-events and met with a range of international counterparts including Fiji, Tonga, Chile, Germany, Sweden, and Japan.

The delegation also effectively negotiated for the interests of New Zealand women and girls to be reflected in the agreed conclusions for CSW67.

These were coordinated to include NGO perspectives via the NGO delegate, Norie Ape, and the other NGO representatives present at CSW67. Officials will provide a summary of engagement themes and other outcomes of CSW67 once they return to New Zealand.
