

# Manatū Wāhine Ministry for Women Fortnightly Report to the Minister for Women

## **Current priority outcome areas**

#### Te Mahere Whai Mahi Wāhine Women's Employment Action Plan

#### NZ Women in Exporting, 4 May – planning update

The working group is progressing arrangements for the women in export event. Invitations to attend the event in-person should be sent this week, and will be followed by promotion for zoom attendance on MFAT, NZTE and Manatū Wāhine media channels.

#### Meeting with MBIE's Sector Workforce Engagement Programme (SWEP)

Staff from SWEP contacted Manatū Wāhine to ask if we knew of an overarching group representing / coordinating the various 'women in ..' groups. SWEP are based in the Regional Economic Development and Investment Unit in Auckland. The unit was established (prior to COVID-19) to investigate ways to encourage New Zealanders into jobs traditionally filled by migrants.

SWEP are active in the following industry sectors: viticulture; road freight; construction; red meat; tourism; horticulture; and agriculture. They travel extensively to the regions and work to raise awareness of the sorts of roles these industries offer and to promote these as a career to be considered.

They have noted the lack of women in these sectors and that, where there are women, how the women have formed 'women in....' groups that work to promote diversity, training, visibility, and the provision of better facilities for women. We advised that we are not aware of an overarching group. The possibility of establishing one was discussed. We offered support for this and provided additional names for them to contact.

Supporting women in employment aligns with Te Mahere Whai Mahi Wāhine actions. On-going contact with SWEP will also provide valuable insights into women's non-traditional employment.

### System leadership - national

#### **Pay Equity**

The data collection undertaken by the Pay Equity Taskforce for the pay equity settlement extension process has concluded. This process, the first of its kind at this scale, has been open for 7 weeks. The aim was to identify all the providers, funded by Government who employed social workers or those in social work roles.

Over 550 providers engaged with the team over this time to determine their eligibility 9(2)(f)(iv)

#### Launch of Community Sport and Recreation Fund for Women and Girls

The launch of Manatū Wāhine's Community Sport and Recreation Fund for Women and Girls has been confirmed for Monday 1 May.

Our Community Fund supports not-for-profit community organisations to improve women and girls' access to sports and active recreation. The fund aims to support women and girls who face intersecting barriers or who are not well supported by mainstream programmes.

You will launch the community fund at an event at the Innermost Gardens hall in Mount Victoria which will be co-hosted by World Off-Road Riding Department (WORD) and Manatū Wāhine.

WORD has created an initiative aimed at developing the confidence of girls and young women and fostering a lifelong love of mountain biking, and is a great example of the kind of initiatives this fund is aimed at supporting.

The launch will be accompanied by a media release and photo opportunity with some of the girls and young women involved in the initiative.

Invitees to the event include representatives from Recreation Aotearoa, Nuku Ora, Shift, Ignite, Yes Disability, YWCA and WISPA. Representatives from MBIE, FIFA Women's World Cup 2023™ Australia and New Zealand, and NZ Football will also be invited to attend the launch.

#### Report on the Wāhine Māori Economy

We commissioned BERL to undertake a report on the Wāhine Māori Economy. This report uses IDI data to quantify the full economic ecosystem relating to wāhine Māori and their whānau, from the earnings (income, goods and services, benefits received, etc.) coming into households, as well as the contributions wāhine and their whānau are making to the New Zealand economy (labour, goods and services, taxation, etc.).

The report also measures wāhine's contribution to Māori collectives such as hapū and iwi, and will quantify the unpaid work performed by wāhine Māori.

The full draft report, with finalised calculations, is due to be delivered by BERL by 9 June this year.
