Update on Te Mahere Whai Mahi Wāhine

We are currently reviewing the progress on Te Mahere Whai Mahi Wāhine since it was launched in June 2022. As part of this work, we met with interested members of NACEW to discuss what would be appropriate indicators of success. NACEW recommended that both qualitative and quantitative indicators, using data and describing women's experiences, would add value. We will meet with the group again as we progress through the review of the Plan. We will also provide you with an implementation update in May.

Women in Governance Summit, 17 August 2023

System leadership - International

Ninth periodic CEDAW report

Consultation on the draft CEDAW report ended on 24 March. Manatū Wāhine received 22 written submissions, and held five online hui with interested parties to hear a range of feedback on the report and about key issues facing women and girls in Aotearoa. This covered a broad range of organisations, including one representing disabled women, the Human Rights Commission, and the international women's caucus. The feedback received is being reflected in the report as appropriate, and agencies will be given a further opportunity to update and review their content. We are aiming to get a final report to your office in early June, prior to submission to the United Nations in July. We will continue to update you on this process.
