

Current priority outcome areas

Update: 68th session of the Commission on the Status of Women

Since our December briefing [MW BR 23-24 0072] confirming your in-principle attendance to the 68th session on the Commission on the Status for Women (CSW68), we have received the programme of work from the CSW Bureau. This outlines key agenda items such as the Ministerial Roundtable themes. As outlined in the fortnightly report on 22 December 2023, the International Women's Caucus (Caucus) is finalising the recommended NGO delegate and are planning the first 2024 Caucus meeting for Tuesday 13 February. You will be invited to attend this meeting and provide opening remarks. We are also arranging a call with the New Zealand Permanent Mission to the United Nations in New York next week, to progress arrangements for the New Zealand delegation's attendance, including visa processes.

The updates outlined above will be covered in a briefing on CSW68 preparation in late January, for your consideration and agreement. The briefing will also include:

- the proposed New Zealand delegation, including the independently selected NGO delegate,
- draft statements informed by national priorities,
- information about travel arrangements.

Nominations service insights survey to be launched next month

The Ministry has developed an online insights survey seeking feedback from nominations service database members about how they find the service and how we might be able to make improvements. There is also an opportunity for both database members and non-members to provide feedback about their own experiences in governance and how women might be better supported into governance roles.

The Ministry has 1,600 members on its nominations service database, and we work closely with other population agencies to deliver online workshops and other opportunities that are informative to database members who are seeking governance roles. We have delivered six workshops in the past year, with over 550 participants.

We are currently developing a nominations service training programme for 2024. In developing our training programme, we include feedback from women about what can best support them. A recent survey on nominations services conducted by Women on Boards NZ, revealed that most respondents (almost 70 percent) wanted more support on finding governance roles and the application process. It also highlighted that a number of respondents felt unsure and under-experienced to apply for governance roles. It is anticipated that the survey results will feed into our training programme in 2024 and further service development.

The survey results will be shared with other government nominations services and public sector boards where appropriate. We will also publish a high-level insights report in the first quarter of 2024, which we will share with all our database members.

We are planning to launch the survey in February.

Letters of congratulations for New Year Honours recipients

This year's list of New Year Honours recipients (released on 30 December 2023) contains 151 recipients – 74 of whom are women. In addition to highlighting the work of women in services to sport, education, the arts, health, and business, it also highlighted the work some women have done to support other women in areas such as governance, domestic violence, and addressing the gender pay gap.

The Ministry is drafting letters of congratulations on your behalf for all 74 women recipients.

Mana Wāhine Kaupapa Inquiry research programme summary

The Minister for Women, alongside the Minister for Māori Economic Development have joint portfolio responsibility for the Wai 2700 – Mana Wāhine Kaupapa Inquiry. Manatū Wāhine Ministry for Women and Te Puni Kōkiri are the joint-lead Crown agencies for the Inquiry.

As requested at our meeting on 20 December 2023, please find a summary of the full research programme below.

The Waitangi Tribunal panel is supervising seven of these research projects as set out in the table. The Joint Research Committee (representatives from the claimant community) are supervising the other six research projects.

Judge Sarah Reeves, Professor Linda Tuhiwai-Smith, Kim Ngarimu, Dr Ruakere Hond and Dr Robyn Anderson are the members of the Waitangi Tribunal Panel.

The role of Ministry for Women is to facilitate and support the procurement process on behalf of the Joint Research Committee.
