

#### OFFICIAL INFORMATION ACT REQUEST

I refer to your official information request of 10 September for:

- The total number of staff sent to courses run by wall walks in each of the last three years.
- Please break down number of staff sent by year.
- Please indicate what course/workshop/training each staff member was involved in is called.
- The total amount spent on sending staff to Wall Walks courses over the last three vears.
- Please break the total amount spent on sending staff to Wall Walks courses down by year.
- The value of any other funding provided to wall walks, broken down by date, funding purpose, office location and amount.
- Please provide emails, reports, messages or any other correspondence for the reasoning of staff being sent on these courses and specify whether participation in these courses was compulsory or not.
- Please provide a copy of documentation including but not limited to emails, reports, messages or any other correspondence that explains the content included in the course or description of activities undertaken through wall walks, or any associated courses/training.
- Please provide emails, reports, messages or any other correspondence for any measurable outcomes from your agency attending Wall Walk courses.

The information you have requested is enclosed. However, we have decided to withhold course materials under section 9(2)(b)(ii) of the OIA (would be likely unreasonably to prejudice the commercial position of the person who supplied the information).

Manatū Wāhine Ministry for Women is committed to supporting our staff to develop their cultural competence and capability so we can better support and effectively engage with our communities.

See the below table for the number of staff attending, and costs associated with the Wall Walks by year:

Year	Number of staff	Cost (exl GST)
2024	8	\$535.65
2023	22	\$1473.05
2022	41	\$2746.18

Staff participation in the Wall Walk is voluntary. Emails were sent to staff to gage participation interest (See Appendix 1).
