#### International Women's Caucus meeting 11 February 2025

The first International Women's Caucus meeting for 2025 is taking place on Tuesday 11 February 2025 at Parliament.

The Ministry is co-hosting the meeting with UN Women Aotearoa New Zealand, who will be delivering a presentation on their organisation's work. There is a placeholder in your diary from 12.15-12.45pm for you to address the Caucus. You may wish to speak about your priorities for the Women portfolio and goals for the year. We will be providing you with an Aide Memoire to support your participation at this meeting next week.

#### 90 women recognised in the 2025 New Year's Honours

The Ministry is drafting congratulatory letters on your behalf for the 90 women who were recognised in the 2025 New Year's Honours. With a total of 189 recipients, women accounted for 48% of the Honours received.

Women were recognised for their work and service across a number of areas including sport, health, business, governance and the fashion industry. Three women were awarded to be Dame Companions of the New Zealand Order of Merit, including Dame Lydia Ko, who is the youngest recipient of this honour in New Zealand.

#### Ovarian cancer awareness month

This February is ovarian cancer awareness month. The theme for this year is "show up for ovarian cancer." The focus in February is making sure that women have the tools, knowledge and support they need. We plan to use our social media to raise awareness and educate about knowing the signs of ovarian cancer and how to get support. The Ovarian Cancer Foundation will be sharing their key messages and information in advance with us so we can use this in our online awareness raising.
