




2024 stocktake of gender and ethnic diversity on public sector boards and committees



Forewords



The 2024 stocktake of gender and ethnic diversity on public sector boards and committees shows that women's representation in public sector governance remains strong.

As at December 2024, women hold 52.1% of public sector board positions – making this the fifth consecutive year women's representation on boards has been above 50%.

Women also continue to be well-represented in Board chair positions – at 44.5%.

This is a great achievement, but the work is not done. It's taken a deliberate and coordinated effort to achieve this. We continue to focus on ensuring we have gender-balanced boards appointed on merit that result in better governance practices, decision-making and financial performance and, ultimately, better outcomes for New Zealanders.

I want to see women continue to be appointed to government boards and committees so that we have the necessary range of experience, skills, and perspectives for good governance.

I'd like to thank my Ministerial colleagues for their contribution to these results and the businesses and organisations supporting and championing women in leadership.

The 2024 stocktake shows that gender diversity is becoming more embedded in the public sector.

This is now the fifth consecutive year that women's representation on public sector boards and committees has reached over 50%.

Māori and ethnic diversity of public sector boards has increased since data collection for ethnicities on boards began in 2019. It is an excellent result, and I'd like to thank everyone involved.

Having more women in leadership positions can bring about greater diversity, better governance and decision-making, and more innovation and performance.

Growing the leadership pipeline is crucial to identifying and promoting a pool of talented women at every level who are ready to step into public and the private sector governance roles.

The Ministry is continuing work to attract new women onto its Nominations Service database, build the Service's offering and outreach, and broaden the range of resources on our Leadership Learning Hub to grow leadership and governance skills.

The 2024 stocktake is the result of dedicated work by appointing agencies and the wider public service, as well as the talented women who continue to demonstrate their leadership and value in various governance roles.



Overall results

Gender and ethnicity data

As at 31 December 2024, women held **52.1%** of Cabinet appointed public sector board and committee roles. This is compared to 53.9% in 2023 and 53.1% in 2022.

This represents the **fifth year in a row** in which women's representation on public sector boards and committees has been at 50% or above.

Ethnicity data was provided for 2,227 board roles, or 98.7% of appointed members (compared to 97.5% in 2023).

The 2024 data shows that members (all genders) are:

- 68.1% NZ European or European (compared to 66.9% in 2023).
- 27.2% Māori (compared to 27.5% in 2023).
- 6.8% Pacific (compared to 7.0% in 2023).
- 6.2% Asian (compared to 6.1% in 2023).
- 0.6% Middle Eastern, Latin American and African (MELAA) (compared to 0.8% in 2023).

Gender breakdowns by ethnicity:

- Of 1,516 roles held by NZ European or European members, 765 roles (50.5%) were held by NZ European or European women.
- Of 605 roles held by Māori members, 339 roles (56.0%) were held by wāhine Māori.
- Of 152 roles held by Pacific members, 88 roles (57.9%) were held by Pacific women.
- Of 138 roles held by Asian members, 85 roles (61.6%) were held by Asian women.
- Of 14 roles held by MELAA members, 6 roles (42.9%) were held by MELAA women.

Overall results

Individual members holding multiple roles by gender:

- 1,965 members held 2,257 roles. 1,176 board roles were held by women, 1,077 roles were held by men, and 4 board roles were held by people who do not identify with a gender.
- 1,011 women held 1,176 board roles. Women made up 51.5% of all individuals holding roles.

Individual members holding multiple roles by ethnicity:

- 1,937 individuals provided ethnicity data (98.6%).
 - o 1,319 NZ European or European people held 1,516 board roles. NZ European or European people made up 68.1% of all individual members.
 - o 660 NZ European or European women held 765 board roles. NZ European or European women made up 34.1% of all individual members.
 - o 502 Māori people held 605 board roles. Māori made up 25.9% of all individual members.
 - o 280 wāhine Māori held 339 board roles. Wāhine Māori made up 14.5% of all individual members.
 - o 125 Pacific people held 152 board roles. Pacific people made up 6.5% of all individual members.
 - o 70 Pacific women held 88 board roles. Pacific women made up 3.6% of all individual members.
 - o 109 Asian people held 138 board roles. Asian people made up 5.6% of all individual members.
 - o 65 Asian women held 85 board roles. Asian women made up 3.4% of all individual members.
 - o 11 MELAA people held 14 board roles. MELAA people made up 0.6% of all individual members.
 - o 6 MELAA women held 6 board roles. MELAA women made up 0.3% of all individual members.

Overall results

Board chairs

There were 301 appointed members identified as board chairs, either on the organisation forms provided or on boards' or agencies' websites. Of these, 134 (44.5%) were women (compared to 46.2% in 2023). 300 (99.7%) provided ethnicity data.

Ethnic breakdown of women board chairs:

- 97 were NZ European or European (72.9%).
- 39 were Māori (29.3%).
- 8 were Pacific (6.0%).
- 4 were Asian (3.0%).
- None were MELAA.
- 1 chair specified an "Other" ethnicity.
- 1 further chair preferred not to specify their ethnicity.

New appointments

There were 424 new members recorded in 2024. Of these, 182 (42.9%) were women. Ethnicity data was received for 406 of the new members (95.8%).

Ethnic breakdown of new members (all genders):

- 67.7% were NZ European or European.
- 21.9% were Māori.
- 5.4% were Pacific.
- 7.6% were Asian.
- 0.5% were MELAA.

The stocktake is dated 31 December 2024. It includes only New Zealand Ministerial appointments that are required to be considered through the Cabinet Appointments and Honours Committee (APH) or other Cabinet committees. The stocktake does include appointments made by the Governor-General on the recommendation of a Minister. It does not include members who have been elected, appointed as members of professional groups without Ministerial right of approval, ex-officio members, or current Members of Parliament. The stocktake does not include temporary boards or committees (i.e. bodies set up for a particular project that is expected to take no more than approximately 18 months and are intended to disband as soon as that December 2024, are not included in total board numbers. Boards are listed by the portfolios which appointed to them as at 31 December 2024.

Methodology

Manatū Wāhine Ministry for Women undertakes this stocktake of gender and ethnicity on public sector boards and committees annually.

Ministerial appointments to public sector boards and committees are counted as at 31 December each year, with data taken from organisation forms submitted by agencies to the Department of the Prime Minister and Cabinet. The current stocktake is dated 31 December 2024 and reports on all appointed members of permanent or ongoing boards, and other appointed roles, as of that date. Where boards are summarised by portfolio, they are listed by the portfolios which appointed to them as at 31 December 2024

The stocktake includes only New Zealand Ministerial appointments considered through Cabinet's Appointments and Honours Committee (APH), or other Cabinet committees. It does not count non-appointed members such as elected or ex-officio members. It also does not count temporary boards appointed for periods of 18 months or less.

Appointing agencies were contacted by Manatū Wāhine Ministry for Women to provide clarity on board membership where necessary, and all agencies were given an opportunity to review and confirm their member data.

Board members self-identified their own ethnicity data and were able to specify multiple ethnicities. Ethnicity data has been coded in keeping with the relevant Stats NZ classification. Members who preferred not to divulge ethnicity data were recorded under the category "Do not wish to specify". All ethnicity data percentages provided refer to the proportion of total members who reported ethnicities.

Throughout 2024, 27 boards were reclassified as exempt from consideration by Cabinet's APH Committee, and a further 24 boards were disestablished. Boards or roles which were entirely vacant as of 31 December 2024 are also not listed here. As a result the 2024 stocktake contains data for 52 fewer boards than in 2023, and 533 fewer members.
