

# Fortnightly Report Minister for Women

### **Current priority outcome areas**

#### Gender Pay Gap confidence survey deadline extension

There has been a good response to the Gender Pay Gap confidence survey that is underway. Prior to Easter there were over 400 responses. We have extended the deadline to Thursday 24 April and are doing one final push for responses through our networks. Once the survey has closed it will take three to four weeks to analyse the results and compile an overview report. The early signs are that there is a good spread of responses across sectors and across private, public and not-for-profit organisations.

#### Roadshow QR survey responses - Timaru and Nelson

Eight attendees participated in the Timaru gender pay gap survey. Half of these respondents reported that they had calculated their gender pay gap in the past year. Among these, only one reported the result internally, and one planned to report publicly in the future. The majority either didn't report or weren't sure.

Three respondents felt confident about knowing how to calculate their pay gap. Five were aware of the GPG toolkit, though just one had actively used the resources.

In Nelson we only had four responses to the survey. Of those, none had calculated their gender pay gap in the past year, but 75% of respondents were aware of the toolkit and felt confident in how to calculate their gap.

#### Refresh of the Nominations Service database nearing completion

The project to ensure all women registered on the Nominations Service database are active and available for board appointments is nearly complete and we will soon know the number of active database members. We will provide you with a briefing with options for setting a target to increase database members before you present the Cabinet paper on the 2024 stocktake of gender and ethnic diversity on public sector boards and committees to the Appointments and Honours Committee.

#### Mana Wāhine Kaupapa Inquiry – Hearings update

Last Thursday 17 April 2025, the Waitangi Tribunal hosted a judicial conference for claimant and Crown counsels to confirm the first hearing week and general approach to address claim concerns.

The Crown position is that we are open to proactively and collaboratively working with claimants by ensuring a joined-up understanding of specific claim issues and working toward potential acknowledgments and/or solutions. Claimants could be amenable to collaborating so we can work through an agreed approach to resolving claim issues. Timeframes for these pieces of work are under consideration and a confirmed approach is expected by the end of May 2025.

It is expected that approximately eight to 11 weeks of hearings will be required to allow claimants to share evidence and ensure the Crown have sufficient time to respond. The first hearing week is scheduled for 3–6 June 2025 at the Victoria University marae in Wellington.

#### Next International Women's Caucus (IWC) meeting scheduled for Tuesday 20 May 2025

Dellwyn Stuart, YWCA, will co-host the next IWC meeting with the Ministry during Youth Week in Wellington (location TBC). While the agenda is still being finalised, young women from their Y25 programme will be invited to attend and may present. The six-month programme brings together 25 young trailblazing women each year and provides mentorship and support from the Y's network.

A placeholder is currently in your diary for 3.20–3.50pm and we will stay in touch with your Office on arrangements. Other agenda items include an overview of the recent Commission on the Status of Women (CSW) and an update on the development of the National Action Plan on Women, Peace and Security being led by MFAT.
