Current priority outcome areas

Strong engagement with 'Free to Lead' toolkit following its launch

The launch of the new 'Free to lead' toolkit on Thursday 1 May received good national media coverage. RNZ covered the launch in its news bulletins, and its 'The Detail' podcast featured interviews with Auckland councillor, Josephine Bartley, and broadcaster, Polly Gillespie, exploring the issue of online harm for women in public life. Coverage and in-depth interviews with women who shared their experiences as part of the toolkit also ran on TVNZ's Breakfast, More FM, in The Post and on the Stuff website.

The toolkit received strong engagement across social media, particularly on Instagram and LinkedIn. The Ministry's accompanying launch videos have reached over 20,000 views on Instagram.

On LinkedIn, the launch generated discussion and a high number of reposts. Notable engagement came from Women on Boards NZ, Global Women, TUANZ, the Government Women's Network, Zonta Club of Wellington, government agencies and the women featured in our video series.

Insights from Canadian experts on supporting women entrepreneurs

On Friday 2 May 2025, the Ministry for Women and the Ministry of Business, Innovation and Employment met virtually with Dr Wendy Cukier, Professor of Entrepreneurship and Innovation at Toronto Metropolitan University, to discuss different approaches and interventions to support women entrepreneurs.

Dr Cukier leads the Women Entrepreneurship Knowledge Hub, and shared context on Canadian government initiatives, including the Women's Entrepreneurship Strategy, that have helped to almost double the rate of women entrepreneurs in Canada.

Key points from the meeting included:

- Evidence that the success rate and return on investment of women-led investment consortiums outperforms other funding bodies.
- Women-led business tend to have strong community and social benefits which can be undermeasured.
- Media analysis undertaken by the Institute shows that ideas around what innovation and entrepreneurship could look like has shifted over the years, but stereotypes remain.

The Ministry is continuing to explore possible activities and actions to support women entrepreneurs, including working with organisers of the upcoming Electrify Aotearoa event in July.

Menopause Forum

Ministry officials attended a Menopause Forum at Parliament on Tuesday 6 May 2025. You had met with some of the event organisers and speakers earlier in the day. Attendees included Members of Parliament, such as Health Select Committee Chair Sam Uffindell and Catherine Wedd who hosted the event. Speakers included Nikki Bezzant (author and advocate), Dr Linda Dear (menopause doctor), Sarah Hogan (author of NZIER's report on menopause *The Silent Transition*), and Dr Sylvia Rosevear (Gynaecologist and President of the Australasian Menopause Society). The speakers presented information on menopause, including its health and economic impacts, and called for better information and support for women experiencing menopause symptoms, particularly through GPs.
